## ***Annual Campus Safety and Security Report***

The annual Union College Campus Safety and Security report is created in accordance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, also known as the Clery Act. The function of this report is to properly inform members of the community about crimes reported and committed on the campus and in other locations as described in the Clery Act. The Annual Security and Fire Safety Report includes statistics for the previous three calendar years, whether on-campus or off-campus, surrounding or adjacent properties, as required by the Clery Act. The report includes institutional policies concerning campus security, sexual assault, alcohol and drug use, and other matters. Campus Safety will provide upon request all campus crime statistics as reported to the U.S. Department of Education. ### ***Compiling the Annual Security and Fire Safety Report***

This report is part of the College's commitment to keep campus community members safe and informed on security related policies and procedures, crime prevention programs, crime statistics, victim support services, and student housing fire safety systems and statistics. This report is created in cooperation with multiple offices on campus, including the Office of Campus Safety, the Office of Title IX and Equal Opportunity, the Office of Community Standards & Accountability as well as local law enforcement municipalities. In addition, Union College accepts confidential reporting of crimes and encourages mental-health and pastoral counselors to report statistics regarding these violations of law. This report is produced in compliance with the Higher Education Act and the Clery Act. The crime statistics included have been gathered by the Clery Compliance officers that meet regularly analyzing reports made on Union's two main reporting systems, Maxient and D3.

## ***Clery Crime and Other Definitions***

This report contains references to numerous terms defined in the Clery Act and/or New York law. We encourage you to familiarize yourself with the definitions of these terms, which are set forth here.

**On-Campus** - (1) Any building or property which is owned or controlled by an institution within the same reasonably contiguous geographic area and is used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls; and (2) Any building or property that is within or reasonably contiguous to the area identified in paragraph (1), that is owned by the institution, but controlled by another person, is frequently used by students and supports institutional purposes (examples include food or retail vendor).

**Non-Campus Building Or Property** - (1) Any building or property owned or controlled by a student organization that is officially recognized by the institution; or (2) Any building or property owned or controlled by an institution that is used in direct support of, or in relation to, the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution. This may include term abroad spaces and short stay-away trips and additional campus space such as The Kelly Adirondack Center and Shuttleworth Park as examples. For COVID social distancing and short term housing Washington Square and the Stockade Inn were used in the fall of 2020. These are both outside the area considered to be contiguous to campus.

**Public Property** - All public property, including thoroughfares, streets, sidewalks, and parking facilities, which is within the campus or immediately adjacent to and accessible from the campus.

**Clery Geography** - Includes locations considered to be on-campus, non-campus buildings or property, or public property, as defined above.

**Residential Facilities** - Dormitory and apartment residences at Union College

**Aggravated Assault** - An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness. This also includes assault with disease (as in cases when the offender is aware that he/she is infected with a deadly disease and deliberately attempts to inflict the disease by biting, spitting, etc.).

**Arson** - Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

**Hate Crime** - A crime reported to local police agencies or to a CSA that manifests evidence that the victim was intentionally selected because of the perpetrator's bias against the victim. For the purposes of this section, the categories of bias include the victim's actual or perceived race, religion, gender, gender identity, sexual orientation, ethnicity, national origin, and disability

**Burglary** - The unlawful entry of a structure to commit a felony or a theft.

**Robbery** - The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/ or by putting the victim in fear of immediate harm.

**Drug Abuse Violations** - Violations of state and local laws prohibiting the production, distribution, and/or use of certain controlled substances and the equipment or devices utilized in their preparation and/or use; the unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation, or importation of any controlled drug or narcotic substance; arrests for violations of state and local laws, specifically those relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs

**Liquor Law Violations** - The violation of laws or ordinances prohibiting: the manufacture, sale, transporting, furnishing, possessing of intoxicating liquor; maintaining unlawful drinking places; bootlegging; operating a still; furnishing liquor to a minor or intemperate person; using a vehicle for illegal transportation of liquor; drinking on a train or public conveyance; and all attempts to commit any of the aforementioned (drunkenness and driving under the influence are not included in this definition).

**Weapon Law Violations** - The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices, or other deadly weapons.

**Motor Vehicle Theft** - The theft of a motor vehicle. Note: A "motor vehicle" is a self-propelled vehicle that runs on the surface of land and not on rails, and which includes automobiles, buses, recreational vehicles, trucks, motorcycles, motor scooters, trail bikes, mopeds, snowmobiles, and golf carts

**Murder and Nonnegligent Manslaughter** - The willful (nonnegligent) killing of one human being by another.

**Manslaughter by Negligence** - The killing of another person through gross negligence.

**Affirmative Consent** - Affirmative consent is a knowing, voluntary, and mutual decision among all participants to engage in sexual activity. Consent can be given by words or actions, as long as those words or actions create clear permission regarding willingness to engage in the sexual activity. Silence or lack of resistance, in and of itself, does not demonstrate consent. The definition of consent does not vary based upon a participant's sex, sexual orientation, gender identity, or gender expression.

**Dating Violence** - Violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim.

(i) The existence of such a relationship shall be determined based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship.

(ii) For the purposes of this definition -

(A) Dating violence includes, but is not limited to, sexual or physical abuse or the threat of such abuse.

(B) Dating violence does not include acts covered under the definition of domestic violence.

(iii) For the purposes of complying with the requirements of this section and § 668.41, any incident meeting this definition is considered a crime for the purposes of Clery Act reporting.

**Domestic Violence** -

(i) A felony or misdemeanor crime of violence committed -

(A) By a current or former spouse or intimate partner of the victim;

(B) By a person with whom the victim shares a child in common;

(C) By a person who is cohabitating with, or has cohabitated with, the victim as a spouse or intimate partner;

(D) By a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred,  
or

(E) By any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred.

(ii) For the purposes of complying with the requirements of this section and § 668.41, any incident meeting this definition is considered a crime for the purposes of Clery Act reporting.

**Fondling** - The touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental incapacity.

**Incest** - Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

**Rape** - The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.

**Sexual Assault** - An offense that meets the definition of rape, fondling, incest, or statutory rape as used in the FBI's UCR program.

**Statutory Rape** - Sexual intercourse with a person who is under the statutory age of consent.

**Stalking** -

(i) Engaging in a course of conduct directed at a specific person that would cause a reasonable person to -

(A) Fear for the person's safety or the safety of others; or

(B) Suffer substantial emotional distress.

(ii) For the purposes of this definition -

(A) **Course of conduct** means two or more acts, including, but not limited to, acts in which the stalker directly, indirectly, or through third parties, by any action, method, device, or means, follows, monitors, observes, surveils, threatens, or communicates to or about a person, or interferes with a person's property.

(B) **Reasonable person** means a reasonable person under similar circumstances and with similar identities to the victim.

(C) **Substantial emotional distress** means significant mental suffering or anguish that may, but does not necessarily, require medical or other professional treatment or counseling.

(iii) For the purposes of complying with the requirements of this section and section 668.41, any incident meeting this definition is considered a crime for the purposes of Clery Act reporting.

## ***Introduction and Mission Statement***

Union College has issued this report to inform the campus community, visitors and the general public of the College's policies and procedures for campus safety and security. Union College has made a solid commitment to maintain a safe campus environment in which to live, learn and work.

Our mission is to serve the campus community in a manner that is unsurpassed and serves as the standard for others to emulate. Our primary function is to provide an environment that allows visitors, students, faculty and staff to interact in safe and secure surroundings. Our role is to actively support the educational activities of Union College through safety and security services. These services will meet the highest level of customer satisfaction and will constantly strive to anticipate the needs of the customer. The mission will be achieved through leadership, education and quality improvements with constant performance monitoring to reduce service variances and to speed service delivery in a cost-effective manner.

## ***Union College Department of Campus Safety***

Union College maintains its own Campus Safety department, providing security services, available 24 hours a day, seven days a week by calling 518-388-6911. The traffic desk and card access systems supervisor are available Monday through Friday 8:30am to 4:30pm located at 450 Nott Street, Schenectady N.Y. 12308. The community is encouraged to report all crimes or violations of College policy to the Campus Safety department or to local law enforcement. This includes actual, attempted or suspected crimes, or any other emergency situations. Outdoor emergency "blue light" telephones are installed on campus, providing direct two-way contact with the Campus Safety department at all times. These emergency phones are identified by an overhead blue light. A map to the emergency phone locations can be found by following the link on the Campus Safety homepage (<https://www.union.edu/campus-safety>). Escort services are available through Campus Safety as well. Contact information for escorts is located at various on-campus locations. The service is offered to any member of the campus community.

Union College employs a security force consisting of about forty-five staff members. All members of Campus Safety receive extensive training; some have prior law enforcement experience. The Director of Campus Safety shares the responsibility of being on call 24 hours a day, 365 days a year. In case of a serious crime or emergency, the Director is notified immediately and then supervises the response and investigation.

Campus Safety personnel are all New York State-licensed security guards with public safety status only available on College owned property. Campus Safety officers enforce the institution's rules and regulations, with the authority to make citizen's arrests.<sup>1</sup> The Campus

<sup>1</sup> Arrest powers for Campus Safety Officers derive from New York criminal Procedure Law Section 140.30, which provides:

1. Arrest without a warrant; by any person; when and where authorized.

Safety officers receive annual training that includes first aid, CPR / AED, active shooter, sexual assault response, crime prevention, crisis intervention and college policies. The officers provide campus patrols 24 hours a day and are responsible for enforcing safety rules and regulations, supervising fire and safety drills, on campus non-emergency medical transports, vehicle and traffic enforcement, on campus motorists' battery jump start and car lockouts, lost and found management, and responding to emergency situations on campus. In addition, they work closely with the Residential Education staff, Facilities Services staff, and the Student Forum to address quality-of-life issues on the campus.

The Public Safety personnel have received Department of Criminal Justice Services (DCJS) approved academy training. The hours of training equip the officers with the knowledge and ability to enforce the laws of New York State on the Union College campus.

Enforcement powers for Public Safety Officers derive from New York Education Law § 6435. Appointment of private college security officers - See more at: <https://codes.findlaw.com/ny/education-law/edn-sect-6435.html>.

1. Security guards appointed as such campus security officers may exercise within their geographic area of authority as defined hereinafter any or all of the following powers: a) To make a warrantless arrest of a person (i) for any offense when he or she has reasonable cause to believe that such person has committed such offense in his or her presence and (ii) for a crime when he or she has reasonable cause to believe that such person has committed such crime, whether in his or her presence or otherwise, and follow such person in continuous close pursuit into public places beyond the geographic area of authority to make such warrantless arrest; provided, however, that such campus security officers shall comply with the post-arrest procedures set forth in section 140.40 of the criminal procedure law and shall not interfere with an ongoing criminal investigation conducted by any police officer;

- To become eligible for appointment as a private college campus security officer a security guard must first successfully complete a course of instruction in public and private law enforcement approved by the municipal police training council, the security guard advisory council, or the department of state or other comparable course offered or recognized by a department or agency of the state of New York as providing appropriate training for the exercise of the powers enumerated in this section.

---

Subject to the provisions of subdivision two, any person may arrest another person (a) for a felony when the latter has in fact committed such felony, and (b) for any offense when the latter has in fact committed such offense in his presence.

2. Such an arrest, if for a felony, may be made anywhere in the state. If the arrest is for an offense other than a felony, it may be made only in the county in which such offense was committed.

## ***Law Enforcement and Jurisdiction***

Campus Safety works with local, county and state law enforcement agencies, both in the investigation of crimes and in crime prevention. The department is in frequent contact with area law enforcement and EMS agencies regarding crimes and the collection of information that may impact the College and/or may be reported. This includes the Schenectady Police Department, Schenectady County Sheriffs, New York State Police, Mohawk Ambulance services, and the Schenectady Fire Department. The College has a written Memorandum of Understanding with the Schenectady Police Department that outlines proper response and investigation of alleged serious crimes and missing persons.

An additional Memorandum of Agreement is in place that focuses an extra patrol surrounding the College's main campus and adjacent city streets during weekend late evening to early night hours. This includes monitoring the premises of officially recognized student organizations located off campus.

## ***Security and Access***

### ***Residence Halls***

All Union College buildings are equipped with exterior locks, and many buildings have electronic anti-intrusion devices. All residence halls are locked 24 hours a day. All student rooms in residence halls are equipped with locks. Campus Safety patrols the campus 24 hours a day, checking all campus buildings, and placing special emphasis on residence halls during the late night and early-morning hours. The campus is monitored with the assistance of more than 91 exterior cameras, 47 interior cameras, 24 cameras with city maintenance and 45 blue light phones.

Entrances to most campus residence halls are equipped with card reader identification systems, which provide access only to residents and approved staff for maintaining and monitoring hall activity. The residence halls that do not have card reader identification systems are all community based houses. They are equipped with locks on all exterior doors. Services and programs intended to enhance the quality of life and the safety and security of our students are a major priority of the Office of Residential Life and the Campus Safety Department. Safety and security policies and procedures, especially regarding locking individual residence rooms and related precautions, are discussed with residents in crime prevention seminars, in routine meetings conducted by the residential life staff, and in printed materials, which are distributed by the staff.

The Access Control office, located in the Campus Safety Office at College Park Hall, issues all Union College identification cards. Lost cards must be reported to the Campus Safety

Department in person. Dining Services must also be notified. A fee of \$25.00 is assessed for each occasion a card is reported as lost or stolen. Any malfunctioning ID card can be returned to the Campus Safety office for a replacement at no cost to the student. Loss of a room or apartment key may be reported in person to Campus Safety, or to the Community Advisor on duty for the student's residence. A fee of \$50 is assessed for key replacement.

### ***Campus Facilities***

During the academic year, access to buildings is by the individual's assigned ID/access card after 6 p.m. and on weekends. During out of term recesses, academic, administrative, student life and recreational facilities hours are established by the individual academic department and Campus Safety.

### ***Maintenance of Campus Facilities***

The Facilities Department maintains College buildings and grounds with a concern for safety and security. Facilities Services maintains a work order system that allows students, faculty, and staff to electronically submit any maintenance or repair issues to the department so that they can be addressed in a timely manner. These personnel are also trained to assist with emergency response needs should an after hours incident occur. To file a work order, a campus community member may call Facilities directly ([518-388-6181](tel:518-388-6181)) or login to the work order system from the link at <https://www.union.edu/facilities-services>. For urgent issues discovered outside the regular business hours of Facilities, you may also contact Campus Safety at [518-388-6911](tel:518-388-6911).

Campus Safety, in collaboration with the Vice President of Administration & Finance office and Facilities, will conduct a quarterly meeting to assess lighting and safety. Walk-throughs of the grounds in the evening are completed to check for lighting concerns, lamp posts that need repair, or foliage in need of trimming. The recommendations lead to addressing additional emergency phones, cameras or lighting installations.

### ***Reporting Crimes and Emergencies***

Campus Safety can be reached at campus extension 6911 from any campus phone line or from an outside line at [518-388-6911](tel:518-388-6911). Public law enforcement assistance can be reached at 911 from an outside campus line for emergencies and the Schenectady Police Department can be reached at [518-630-0911](tel:518-630-0911) for non-emergencies.

In 2016 the New York Public Service Commission approved an all-services overlay for the 518 area code, which covers all or part of 17 counties in eastern upstate New York. Effective August 19, 2017, a new dialing procedure requires callers to dial the **area code + telephone number** for all local calls within the area served by the 518 area code and the new 838 area code. This means



that calls will need to be dialed using the area code (518 or 838) plus the seven digit telephone number.

A phone is located at the main entrances of most residence halls, and blue light phones are located as stated above and outlined on the [Campus Map](#). One can also report incidents in person to Campus Safety located at 645 Nott Street or the traffic desk of College Park Hall, 450 Nott Street.

If a person is unable to contact Campus Safety directly to report an emergency, that person should notify appropriate College personnel (such as a coach, administrator in charge, or residence hall staff member) who, in turn, will contact Campus Safety. In the case of offenses covered under the Clery Act, an incident that is reported will be reflected in the College's Clery Act-reported campus crime statistics.

In addition to Campus Safety personnel and others identified by the College to receive reports of crimes as described in this report, any official of the College who has significant responsibility for student and campus activities is considered a **Campus Security Authority (CSA)** and must report all offenses. This includes housing and disciplinary staff. Examples of CSA's are Dean of Students, Director of Greek Affairs, Community Advisors, Community Directors, Athletic coaches, Human Resources, Title IX, the Office of Intercultural Affairs, Campus Safety, and club and organization advisors.

### ***On-campus Reporting***

It is important to note that some victims may not want to report crimes to the Campus Safety Department or local law enforcement agencies and instead prefer to report crimes via confidential or anonymous methods. In either case, reported crimes that fall under the Clery Act are included in this annual crime statistics report.

Occasionally, victims of crime wish to report a crime but do not want to give their name and/or do not want to pursue action through the criminal justice or College judicial systems. If a victim of a crime does not want to pursue action within the College conduct system or the criminal justice system, they may still want to consider making an anonymous report. A report on the details of the incident without revealing identity can be filed. The purpose of an anonymous report is to comply with the wish to keep the matter anonymous, while taking steps to ensure the future safety of the community. Please note that in cases involving anonymous reporting, the ability of the College or law enforcement authorities to respond and take enforcement action or other may be limited.

As allowed by the Clery Act, pastoral and professional counselors may receive confidential reports and are not required to report those crimes to Campus Safety for inclusion into the annual disclosure of crime statistics or for the purpose of a timely warning. These positions are defined as follows:

***Pastoral Counselor*** - a person who is associated with a religious order or denomination, is recognized by that religious order or denomination as someone who provides confidential counseling, and is functioning within the scope of that recognition as a pastoral counselor.

***Professional Counselor*** - a person whose official responsibilities include providing mental health counseling to members of the institution's community and who is functioning within the scope of his or her license or certification.

Pastoral counselors and professional counselors, if and when they deem it appropriate, are encouraged to inform the persons they are counseling of the procedures to report a crime to the Union College Campus Safety Department for inclusion in the annual disclosure of crime statistics.

To make a private report about a crime or possible crime and/or College policy violation, contact Campus Safety. While retaining confidentiality, the College may decide if an investigation needs to be conducted by campus safety or a timely warning is required to be sent to the campus community. College professional counselors, physicians, and pastoral counselors are also encouraged, if and when they deem it appropriate, to inform the persons they are counseling or treating of the College's procedures to report crimes on a voluntary, confidential basis for inclusion in the annual disclosure of crime statistics as described below.

***Response to Reports of Crimes and Incidents***

If a crime or incident is reported to Campus Safety, the following steps are taken:

- An officer is dispatched to assess the situation and secure the scene, if needed (campus officers are trained to attend to the needs of victims and to take control of the situation). If the incident warrants, outside services such as the police, EMS, and / or fire department are called. At the scene, the campus officer is responsible for maintaining

order, interviewing victims and witnesses and preserving evidence until local police arrive on scene if warranted (as stipulated in the MOU to be any violent felony crime, hate crime or as requested).

- In the case of injury or illness, the individual may be cared for at the College's health services facility during hours of operation, or may choose care at the Ellis Hospital emergency room or nearby Urgent Care centers.
- Either the Director or their designee notifies the appropriate Union officials of the incident as needed in accordance with the College's emergency communications plan.
- The investigating officer files a written incident report that is forwarded to the appropriate College officials. The Schenectady Police Department is informed of serious crimes occurring on campus and these may be further investigated by the Schenectady Police Department, New York State Police, or the Schenectady County Sheriff. Outside law enforcement incident information involving students is forwarded to the Dean of Students Office for potential action, as appropriate.
- If an incident is considered serious and poses an immediate threat to people and/or property, an emergency alert will be issued. Communication systems such as email and text may be utilized when appropriate for immediate notification. The information is also provided to the student newspaper.
- In response to a non-emergency call, Campus Safety will take the required action, either dispatching an officer, or asking the victim to report to Campus Safety to file an incident report.

### ***Daily Crime and Fire Log***

The Department of Campus Safety keeps a Daily Crime and Fire Log. This log records all crimes and fire incidents that occurred within the last 60 days on campus including details such as the date the incident was reported, time, incident type and location. It can be found at this [link](#). Crime and Fire Log entries older than 60 days are available upon request to Campus Safety and will be made available within two business days after request.

### ***Security Awareness and Crime Prevention Programs***

Union College offers many programs specifically designed to inform members of the campus community about security procedures and policies, personal safety, and crime prevention. In addition to the student tailored programs, the College offers this information to employees through Human Resources orientation and the Employee Handbook. The Union College Student Handbook is made available to each new student (available online at this [link](#)). It presents information on fire prevention and campus security issues, as well as Union's policies on alcohol and drugs.

## ***Security Awareness Programs (safety procedures)***

- **Community Advisor Training-** CA's undergo annual training in preparation for residential responsibilities that take place during the academic year. The training consists of a series of workshops focusing on safety, security, sexual harassment, College rules and policies, and diversity.
- **Active Shooter Drills-** Union College Campus Safety annually hosts an active shooter drill open to the College community to attend. The College works in collaboration with the Schenectady Police Department to create a safe drill environment.
- **Dorm Room Lockout Services-** Campus Safety will perform dorm lockouts for students during the day who have lost or misplaced their access devices. After hours, Community Advisors that live within the dorms will unlock students' doors for them.
- **Vehicle Jump Start or Lockout-** Campus Safety will perform a lock out or jump start for faculty, staff or students whose vehicles are having automobile issues or who have misplaced car keys. Appropriate waivers must be signed before Campus Safety can complete their services. Officers will bring the appropriate paperwork with them on the call. This service is provided 24/7 and can be accessed by calling Campus Safety ([518-388-6911](tel:518-388-6911)).
- **New Student Orientation-** All incoming new students participate in Orientation programming which covers the topics of alcohol and drug use, consent, bias, sexual misconduct including sexual assault, stalking, dating violence, and domestic violence.
- **New Hire Orientation-** New hire orientation is for new employees to hear from representatives from key areas across the College (CHRO, CDOs, Title IX, Facilities, Campus Safety, EHS) about the services and support they provide to the community. In addition, attendees learn more about employee benefits and wellness offerings, the HR team, and the College's history, mission, vision, community values and DEIB goals.

## ***Crime Prevention Programs***

- **RESIST** - Union College created a self defense program conducted by Campus Safety that teaches all who attend situational awareness, policies and procedures on and off campus, and basic self defense tactics.
- **Campus Safety Escorts** - Campus Safety provides escorts to individuals on campus who request it. These escorts may be walking or by vehicle and are offered 24/7.
- **Trolley Bus Service** - The trolley bus service consists of a fleet of buses provided by the Transportation Department. The trolley schedule can be found here at <https://www.union.edu/campus-safety/trolley-stops-and-operation>.
- **Trolley Tracker** - The Trolley Tracker is a service you can access online at <https://portal.gpsinsight.com/d/publicmap.php?key=gpsi5c8969cfb4702>. The Trolley Tracker enables a community member to wait safely inside before their trolley arrives at their designated trolley stop.
- **Lost and Found** - Campus Safety can receive and report lost and found items any time of the day. Items are logged within a system and kept in a locked facility for safekeeping until an owner can be contacted.

- **Emergency Blue Lights and Phones** - Union College has 36 blue light phones located throughout campus. These phones place the caller in contact with the Campus Safety dispatcher in case of an emergency. In addition to the caller being able to speak with a dispatcher, officers are immediately sent to the area.
- **"Campus Crime Report"** - A weekly report featured in the student newspaper, the *Concordiensis*, is an important element of our crime prevention efforts. Keeping the community informed and aware of the nature and volume of criminal offenses reported on campus constitutes one of our most valuable crime prevention efforts.
- **Crime Awareness Bulletins** - In the event of a serious crime, bulletins are issued by the Dean of Students Office and the Campus Safety Department.
- **County Camera Group** -The Director of Campus Safety meets with Schenectady County officials semi-annually to review and research monitoring needs for the surrounding portions of the city.
- **Local Emergency Planning Committee (LEPC)** - Monthly, the Director of Campus Safety meets with a group of County and City Emergency Responders, Red Cross, and various local businesses and schools to discuss issues the county is currently facing. Director Constantine is currently the Managing Director of the LEPC.
- **Shen-TAT** - The Director of Campus Safety, along with representatives of many other schools, businesses, and task forces meet monthly to discuss local threats within the area. The forum allows agencies to discuss areas of concern or people of interest while simultaneously allowing other agencies to cross reference their reporting systems to see if they have also had issues with that individual.
- **Annual Fall Sports Safety Conversation** - At the beginning of every fall semester, representatives from the Department of Campus Safety, the Office of Title IX, and the College's Athletics Compliance Officer meet with each athletic team to discuss various health and safety measures at the College.

### ***Drug and Alcohol Awareness and Education***

Union College provides educational programs and activities, which are designed to provide information about the effects of alcohol and illicit drug use on the individual and on the life of the community. Educational programming begins with New Student Orientation and is further promoted by joint programming sponsored by the Office of the Dean of Students and various student organizations as well as the Office of Residential Education. Students found in violation of the Alcohol and Drug Policy are required to attend an Alcohol and Substance Abuse awareness program.

### ***Responsible Employee Reporting***

All Union College employees, including faculty, staff and administrators, except those designated as confidential resources, are identified by College Policy as "Responsible Employees", and are required to share with the Title IX Coordinator any report of conduct

prohibited by Title IX they receive or of which they become aware. Having a wide range of individuals that can support a student in making a report of conduct prohibited by Title IX ensures that students can approach an employee they know and trust. For more information regarding Responsible Employees and their responsibilities, please visit: [www.union.edu/titleix](http://www.union.edu/titleix).

The Campus Safety department will alert the Title IX Coordinator if a complainant does choose to report directly to the Campus Safety department. The College will make available resources, on-campus/off-campus or both, including medical and health resources, to persons who have been victims of sexual assault, domestic violence, dating violence, or stalking, and will apply appropriate disciplinary procedures to those who violate College policy. The procedures set forth below are intended to afford a prompt response to allegations of sexual assault, domestic or dating violence, and stalking, to maintain confidentiality and fairness consistent with applicable legal requirements, and to impose appropriate sanctions on violators of this policy.

### ***Timely Warnings***

The Campus Crime Alert (“Alert”) is provided to give students, faculty, and staff timely notification of crimes that may represent a serious or ongoing threat to the campus community and to heighten safety awareness. The Alert may also seek information that may lead to the arrest and conviction of the offender when violent crimes against persons or substantial crimes against property have been reported. The alert will withhold any victim(s) names, if applicable.

Campus Safety is responsible for issuing a Campus Crime Alert when a crime is reported to or brought to the attention of Campus Safety or other campus security authorities and that crime represents a serious or ongoing threat to the safety of members of the campus community. Information for an Alert may also come from other law enforcement agencies. Every attempt will be made to distribute the Alert promptly; however, the release is subject to the availability of accurate facts concerning the incident. Alerts are created and distributed by Campus Safety and/or the Vice President for Student Affairs and/or Vice President of Finance and Administration or his/her designee with the assistance of Telecommunications and/or Communications in compliance with the Clery Act.

### ***Timely Warning Procedure***

The Director of Campus Safety, with assistance as needed from the Vice President of Finance and Administration, and the Vice President for Student Affairs (or designee), determine when and how to issue timely warning notices. They determine the content of the notification and initiate the notification system. The only time a notification may be delayed is if it compromises efforts to assist, respond or otherwise mitigate an emergency.

Campus Safety will prepare a Campus Crime Alert whenever a report is received of a violent crime against a person or a substantial crime against property on or near campus that represents a serious or ongoing threat to the safety of students, faculty, and staff. Alerts are assigned the same number as the corresponding Campus Safety report and provide details of the crime, a description of the suspect (if known), and information on whom to contact.

Campus Crime Alerts will be emailed and/or texted as quickly as possible to faculty, staff and students. When it is confirmed that a serious emergency or dangerous situation exists, relevant information will be disseminated to the College community by one or all of a variety of means. These include; a siren system, loudspeakers, emergency cellular text messaging system, emails, web site postings, and personal contact. Communication systems are tested on every third Wednesday of each month at 1pm. Students and staff are also provided instruction and training in emergency procedures, including evacuation drills throughout each year.

Whenever the Schenectady Police Department informs Union College about an off-campus crime that represents a serious or ongoing threat to the safety of students, faculty, and staff, the College will assist in publicizing the crime on campus.

Campus Crime Alerts typically include the following information:

1. A description of the incident.
2. Any connection to previously reported incidents.
3. Physical description and/or composite drawing of the suspect, if appropriate.
4. Date and time the Alert was released.
5. Other relevant and important information.
6. Appropriate safety tips.

### ***Emergency Notifications***

Under the Clery Act, colleges and universities use timely warnings and emergency notifications to inform the campus community of potential threats against which they can take preventive measures. These ongoing disclosure requirements, when implemented, can help to create and promote a safe campus environment.

**Emergency notifications** are triggered by a far broader range of potential threats — any significant **emergency** or dangerous situation involving an immediate threat to the health or

safety of students or employees on the campus. Emergency notification messages will have a close out message informing the community the emergency is over / resolved.

## ***Emergency Management Procedures***

Departments involved in fulfilling the obligations of these Emergency Management Procedures include: President's Office (Chief of Staff), Campus Safety (Director of Campus Safety), Dean of Students Office (Vice President of Student Affairs), and Office of Communications (Vice President for Communications and Marketing and/or Director of Media and Public Relations).

There is a separate procedure governing timely warning notices that are sent to the Union College community to notify members of the community about serious crimes against people that occur on campus when it is determined by Union administrators that the incident may pose an on-going threat to members of the Union College community.

In the event of any crisis that affects the Union College campus, the following steps will be taken immediately to assess and develop a response plan. Union College's primary consideration is the safety, health, and security of the campus community.

## ***Level of Emergencies***

The Emergency Management Procedure (EMP) is designed to provide guidelines for responding to a variety of incidents and emergencies that affect the College. Not all emergencies require the same degree of response, and each incident will be evaluated on a case-by-case basis.

### ***Emergency Level definitions***

**Limited Emergency** — A campus emergency with limited impact that does not affect the overall operation and function of the College. Examples would include a minor hazardous material incident, small fire, or temporary limited power outage. A Limited Emergency will not normally entail notification of the Emergency Management Team except through routine communications.

**General Emergency** — A local emergency that has disrupted or potentially may disrupt significant operation of the College or adversely impact a major population of the community. Examples include serious crimes on campus, major fires, death(s), or partial infrastructure failure. A General Emergency may entail Union College Emergency Response Alerts.

**Major Emergency** — A community-wide emergency that potentially disrupts the operations of the College and involves major damage or systems failure. Major Emergencies typically impact not only the College, but possibly the surrounding community and beyond. Examples



include tornadoes, widespread extended power outage, severe natural disasters, or serious acts of terrorism. A Major Emergency will entail Union College Emergency Response Alerts.

## ***Activating the EMP***

### Initial Notification

- Any community member who witnesses or receives information regarding an emergency is instructed to contact the Campus Safety Department at extension 6911, in person, or from off-campus at 518-388-6911.
- If the incident involves a Level 1 (Limited Emergency), Campus Safety or the appropriate department will take steps to remedy the situation utilizing the appropriate College Departments and outside resources.
- If the incident involves a Level 2 (General Emergency), Campus Safety will contact the Director of Campus Safety, appropriate local emergency response organization and the on-call dean.
- If the incident involves a Level 3 (Major Emergency), Campus Safety will contact the Director of Campus Safety and appropriate members of the Emergency Management Team (EMT) to activate the EMP.

## ***Declaring an Emergency***

When it appears that the incident is very serious:

- Members of the Emergency Management Team will discuss the incident and determine the level of emergency and whether to activate the Emergency Operations Center. The decision to declare an emergency will rest with the President or his/her designee.
- Any other appropriate members of the community deemed necessary will be contacted to respond.
- After the Emergency Management Procedure is activated, the process moves to a plan Response phase.

## ***Response to Any Level of Emergency***

Immediate emergency decisions will be managed by field supervisors until the Director or Vice President of Administration and Finance is able to take over responsibility.

The President or designee will be notified of any College Level 3 emergency situation. Notification shall be passed to the President by Vice Presidents, Director of Campus Safety or others as deemed necessary in light of the nature of the crisis situation. The

President or designee, along with the proper authority (e.g. local fire and police officials) has final authority for emergency decisions and directives.

The Union College Campus Community Emergency Response Alert System (RAVE) will be activated. This alert system may include campus siren sounds, text messages, cell phone messages, voice mail, campus radio, TV station, email, social media or the College website. Some or all of these methods of communication may be activated in the event of an immediate threat to the Union College campus community.

In a prolonged emergency situation, the President will convene the senior staff at either an on-campus or off-campus for an emergency operations meeting.

In a prolonged emergency situation, the President and the senior staff will review the situation and decide appropriate actions, such as evacuating the campus or specific buildings, canceling classes, closing the College, communicating with the campus and the media, and/or securing emergency procedures.

An Emergency Response Team (ERT), with training and responsibility for managing emergency operations, will be called to the emergency operations center or, if that is not possible, will contact the center by telephone. The ERT is composed of managers with responsibility for major services.

Local police, fire, rescue and/or medical officials will be called to campus to assist as circumstances warrant. The emergency personnel and the campus community will rely on the expertise of these professionals during a crisis.

Emergency Assistance Staff (EAS), with training and responsibility to carry out specific assignments, will receive instructions from either the senior staff or from the Emergency Response Team (ERT) and will assist in implementing emergency procedures. Their duties may include communication, evacuation, directing pedestrian and vehicular traffic, and securing College property.

## ***Communication***

Every effort will be made to communicate a single, clear message simultaneously to as many students, faculty, and staff as possible. Emergency personnel will be trained to communicate information quickly and consistently. The Vice President of Student Affairs, Vice President of Communications and Marketing, Director of Campus Safety, and/or the Director of Media and Public Relations will determine the content of the message and will use some or all of the systems described below to communicate the threat to the Union College campus community (or the appropriate segment of the community if that threat is limited to a particular building or segment of the community).

In accordance with the requirements of the law, Campus Safety and Office of Communication-Public Relations will, without delay and taking into account the safety of the Union College campus community, determine the content of the notification and initiate the notification system, unless issuing a notification will, in the judgment of the first responders (including, but not limited to: Campus Safety, Schenectady Police Department, and Schenectady Fire Department), compromise the efforts to assist a victim or to contain, respond to, or otherwise mitigate the emergency.

Decisions will likely include a determination of the most effective means of communication in light of the situation, e.g. Campus siren sounds, text messages, cell phone messages, voice mail, campus radio, TV station, email, the College website, flyers, or in-person announcement (however, Union College cannot warrant the successful delivery of each message to each individual recipient).

Local TV, radio and newspapers will be contacted if necessary to provide expanded communications. Depending on the crisis, voice mail, email, the College information line [518-388-6000](tel:518-388-6000), and the College's website may be used for official updates (although some forms of communication may not be operable in a given emergency).

Vital information regarding the situation will be communicated and may include the following:

- a description of what has occurred
- preliminary assessment of impact
- immediate course of action
- the urgency of action
- emergency procedures being implemented
- time of safe return to campus or specified campus facilities (in the event of an evacuation)
- emergency numbers and website access
- other significant decisions or information

Emergency messages will be adapted for various constituencies, such as faculty, parents, students, alumni and media.

Certain campus services and support personnel will receive specific instructions relating to their specialized duties.

The President's assistant along with the Director of Media Relations will be responsible for transmitting the President's emergency decisions to a pre-designated communication network composed of emergency personnel.

## ***Evacuation***

After the order to evacuate or to shelter in place, the Vice Presidents will activate

evacuation plans for their respective divisions. These instructions, depending on the emergency, may include the following:

- forward phones
- close and lock doors
- ensure that all building occupants have left
- report completed evacuation to appropriate College officials.

Each office will develop procedures that are specific to its needs and compatible with the College emergency procedures, including securing valuables and records, continuing operations off campus, and establishing communication within the unit.

In the event of the evacuation of the entire campus, the campus community will be informed of the primary evacuation site(s).

Alternative evacuation sites will be designated if primary sites are not available or if the situation requires a long-term evacuation.

Safe-area evacuation sites will be designated for specific building or campus area evacuations.

If medical assistance is needed, contact the Campus Safety office at [518-388-6911](tel:518-388-6911). A dining services contingency plan will go into effect to provide food for members of the campus community who are at the evacuation site(s). The lines of communication outlined in the Emergency Management Procedures are intended for use in emergency evacuation and/or shelter in place situations. They do not replace established College-wide or departmental communication protocols that are used during other types of emergencies (e.g. weather-related closing, etc.)

## ***Evacuation Procedures***

All occupants are required to evacuate the building immediately when a fire alarm sounds or other evacuation signal is given. The last person to leave an office, classroom, or lab will close and lock the door.

## ***Annual Testing***

Campus Safety conducts testing of the College's Emergency Management Procedures at least once per year. These tests may be announced (as in the case of a residence hall fire safety program) or unannounced (as in the case of emergency preparedness drills). Campus Safety will maintain documentation for each test including a description of the exercise; the date, time, and place of the exercise; and whether the drill was announced or unannounced.

## ***Emergency Siren***

An emergency siren is installed on the roof of the Reamer Campus Center. In the event of a Major Emergency of the campus, or complete disruption pertaining to an emergency, the siren will alert members of the campus community to seek additional information through email, text messaging, the College's website ([www.union.edu](http://www.union.edu)), and / or WRUC (89.7 FM.)

## ***Website***

The main Union College home page ([www.union.edu](http://www.union.edu)) may be modified in a Major Emergency to post critical information as quickly as possible.

## ***Public Address System***

A public address system is in place on campus buildings, and most interior academic buildings. It is tested on a monthly basis.

## ***Missing Person Procedure***

**Union College Campus Safety- 518-388-6911**

**Schenectady Police Department- 518-382-5200 (Emergency)**

**Dean of Students- 518-388-5555 (8:30am-5:00pm)**

As soon as a student is suspected of being missing, the situation should be reported to the Campus Safety Department immediately. Upon receipt of a report of a missing student, Campus Safety will conduct a thorough and timely preliminary investigation to verify the report, determine existing circumstances and attempt to locate the missing student. If the investigation has been completed and the student is still missing, the Schenectady Police Department will be notified. In any event, notification to the Schenectady Police Department will be made no later than 24 hours after the student has been determined to be missing.

After a student has been missing for 24 hours, the Campus Safety Department will notify the student's Confidential Missing Persons Contact. Every student has the right to register a Confidential Missing Persons Contact. This information will only be accessible by authorized campus officials and law enforcement. It will not be disclosed outside of a missing persons investigation.

If the missing student is younger than 18 years of age and not an emancipated minor, the institution will notify his/her custodial parent or guardian in addition to the Confidential Missing Persons Contact identified by the student.

Not later than 24 hours after determining a student is missing, the Campus Safety Department will notify the following College officials:

- Dean of Students
- Director of Residential Education
- Director of Campus Safety

### ***Bias-Related Incidents***

Union College informs incoming students about bias-related crime and prevention measures through programs that include workshops, seminars, discussion groups, and orientation sessions. The purpose of these programs is to disseminate information about bias-related crime, promote discussion, encourage reporting of incidents of such crime, and facilitate prevention.

Bias-related crimes are criminal activity motivated by the perpetrator's bias or attitude against an individual victim or group based in whole or in substantial part on perceived or actual race, color, national origin, religion, religious practice, ancestry, gender, gender identity or expression, sexual orientation, age or disability, or other protected characteristics. In addition to preventing and assisting in the investigation for adjudication of hate/bias crimes, Campus Safety also assists in addressing bias related activities that do not rise to the level of a crime. These activities are referred to as bias incidents and may be addressed through College policy, including the campus conduct code. The Policy Prohibiting Bias Acts and the Discrimination, Harassment, and Retaliation web pages outline the College's policies in detail.

**Under New York State's Hate Crimes Law** (Article 485 of the Penal Law), sentencing enhancements are applied to 53 different crimes, such as threats of violence, a physical or violent attack, or property damage, when a defendant is convicted of a hate crime (because the offense is motivated in whole or in substantial part, by the offender's bias against an individual's actual or perceived race, color, national origin, religion, religious practice, ancestry, ethnicity, gender, gender identity or expression, sexual orientation, age or disability). Federal law includes similar provisions for specified crimes based on actual or perceived race, color, religion, national origin, sexual orientation, gender, gender identity, or disability.

### ***Policy Prohibiting Bias Acts at Union College***

Union College is committed to providing a safe living and learning environment in which every person is valued and respected, inclusion is assured, and free expression and debate are encouraged. The College accepts the task of educating the next generation of leaders to understand and appreciate the ideas and opinions generated by an increasingly global community. Policy Prohibiting Bias Acts establishes a mechanism for addressing situations involving a real or perceived bias act. In such an instance, the College desires to proceed thoughtfully, providing support to all of those affected, while also affirming that Union values differences, free expression, and debate as sources of strength for the College community.

### ***Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, as amended by The Violence Against Women Reauthorization Act of 2013***

Union does not discriminate on the basis of sex in its educational, extracurricular, athletic or other programs or in the context of admissions or employment. Sexual misconduct is a form of sex discrimination. This Policy prohibits all forms of sexual and gender-based misconduct, including harassment, sexual assault, non-consensual sexual contact, stalking, and intimate partner violence (“Sexual Misconduct”).

Union College’s commitment to diversity and inclusiveness is grounded in providing an environment that is free from all prohibited discrimination, harassment, misconduct (including sexual assault, stalking, and relationship violence), bias activity, and retaliation. Union’s commitment is intended to prevent negative actions that are directed at a member or group of the Union community because of that individual’s or group’s actual or perceived age, color, creed, disability, ethnicity, gender, gender identity or expression, marital status, national origin, race, religion, sexual orientation, military status, genetic predisposition, domestic violence victim status, and any other factors prohibited by applicable law. Acts of prohibited discrimination, harassment, misconduct (including sexual assault, stalking, domestic violence and dating violence), and retaliation constitute violations of federal and state law.

Union College also prohibits other forms of discrimination and harassment, including discrimination and harassment on the basis of race, color, national origin, ancestry, age, religious belief, marital status, physical or mental disability, medical condition, veteran status, or any other characteristic protected by federal, state, or local law. Such prohibited conduct is addressed in other College policies prohibiting discrimination, harassment and retaliation based on protected status.

Sexual misconduct is a form of sex discrimination. Union College prohibits all forms of sexual and gender-based misconduct, including harassment, sexual assault, stalking, domestic violence and dating violence (“Sexual Misconduct”). The College strives to cultivate a culture of reporting and shared responsibility for responding to incidents of Sexual Misconduct. To this end, College Policy also prohibits retaliation against a person who reports, complains about, or who otherwise participates in good faith in, any matter related to prohibited conduct.

## ***Title IX Reporting***

To respect the autonomy of a person who has experienced sexual harassment, Title IX regulations do not require an institution to investigate sexual harassment allegations until that person files, or the Title IX Coordinator signs, a formal complaint.<sup>2</sup>

Title IX does, however, require institutions to offer supportive measures to the persons involved when the Title IX Coordinator or an "official with authority" has actual notice of sexual harassment allegations. Officials with authority are those employees who can institute corrective measures when a student or employee reports sexual harassment, and "actual notice" means either by direct knowledge or someone reporting an incident.

Under Title IX, school policies may also designate additional employees who "may, must, or must only with a student's consent," report information about possible incidents of sexual harassment or violence, intimate partner violence, or stalking to the Title IX coordinator or other appropriate designee.

Supportive measures are provided to ensure that equal access to educational programs and activities is preserved for the person who reports being sexually harassed, assaulted, abused, or stalked, as well as provide any appropriate supportive measures for the person accused of sexual harassment.

The person making the report will also be provided information about:

- Protection against retaliation (for example, intimidation, coercion, threats, or discrimination) for reporting misconduct, or participating in an investigation or grievance process

<sup>2</sup> The United States Department of Education has promulgated regulations that, effective August 1, 2024, would require certain changes to the Title IX grievance processes and associated College policies and procedures described in this Report. As of the date of this Report, implementation of those regulations at the College, and associated College policies and procedures, has been enjoined by the July 2, 2024 memorandum and order of the United States District Court for the District of Kansas in *State of Kansas v. United States Department of Education et al.* As a result, the College’s policies and procedures, as described in this Report, continue to reflect the applicable requirements of the Department’s prior regulations, which became effective as of August 14, 2020.



- The school’s responsibilities regarding orders of protection, including mutual and one-way no-contact orders, and restraining orders
- How the school will protect the complainant’s and other parties' confidentiality or privacy in any publicly available record-keeping, protective measures taken, and grievance disciplinary process

Questions regarding Title IX or prohibited sexual misconduct may be referred to our Title IX coordinator or to the Department of Education's [Office for Civil Rights](https://www2.ed.gov/about/offices/list/ocr/index.html) (<https://www2.ed.gov/about/offices/list/ocr/index.html>).

It is important to understand the grievance process prescribed by the U.S. Department of Education for determining an employee's or a student's responsibility for committing sexual harassment that violates Title IX.

A school's policies may have additional rules for Title IX hearings — such as limiting the introduction of evidence not produced prior to the hearing or rules requiring respectful cross examination of witnesses — provided that they apply equally to both parties. If a formal complaint is filed by a person alleging sexual harassment (the "complainant ") or signed by a Title IX Coordinator, the proceedings must:

- Be reasonably prompt, fair, and impartial
- Be conducted by unbiased officials who are trained on investigating sexual harassment and conducting grievance or disciplinary proceedings
- Provide both the complainant and the person accused of committing sexual harassment (the "respondent") equal opportunities to:
  - Access information that will be used at formal and informal meetings or hearings, and review any evidence obtained during the investigation
    - Present witnesses and other evidence
    - Have an advisor or other support person present during the grievance process
    - Allow advisors to cross-examine witnesses and parties, and either party to request that they be in separate rooms with technology enabling them to see and hear a witness or party answer questions
- Both complainant and respondent must be notified at the same time of:
  - A statement of, and rationale for, the result of the proceedings and any sanction imposed against the respondent
- Information on how to exercise the right to appeal
- Any change to the result
- When the result becomes final

### ***After A Report Occurs***

When a report occurs, the primary questions driving the Title IX and Equal Opportunity team are: is the person(s) who experiences harm within our community safe and are they well? The primary objectives in the report are to ensure our community members understand their rights and are connected to appropriate support services. When a report is made, the party allegedly

experiencing the harm will be given as much autonomy as possible in making a determination about how a report is addressed or adjudicated. The College can never require a student or employee to serve as the complainant in a formal adjudication, even where the College may be required by law to intervene.

Please be advised that as a reporting party, if you are not the party alleged to have experienced misconduct you are likely not going to be notified of the decisions made by the party or privy to confidential information relative to the report, which may include case outcomes.

Reporting is not the same as, nor does it automatically trigger, an investigation. A case may result in a wide-range of outcomes, all of which prioritize the autonomy of the complainant, the health, safety, and wellness of our community, and our ability to remedy harm.

### ***Procedures For Addressing Complaints Within the Scope of Title IX***

The Office of Title IX is responsible for the oversight of investigations of conduct prohibited by Title IX wherein the person alleged of committing the misconduct (the Respondent) is a student, student group or employee of the College or third-party contractor.

i. Persons Involved in the Procedures for Addressing Complaints within the Scope of Title IX: Advisor of Choice (“Advisor”): at stages under these procedures, students or employees participating as Complainant or Respondent may be accompanied by an Advisor of Choice to any meeting or hearing they are required or are eligible to attend.

Advisors may be any person, including an attorney. The Advisor is not an advocate, except where explicitly stated by the College’s Title IX Policy or its procedures, Advisors may not speak on the party’s behalf, participate directly in the process, or otherwise interfere with meetings or proceedings. Advisors may help the party prepare written submissions, during hearings may confer with the party, and are responsible for conducting the cross-examination of the opposing party and witness(s) on behalf of the party. If a student does not have an advisor for the hearing, one will be provided by the College.

Hearing Facilitator: the Title IX Coordinator, or their designee, will serve as the Hearing Facilitator. The Hearing Facilitator is a non-witness, non-voting representative of the Office of Title IX who is responsible for administrative functions during the course of the hearing including but not limited to coordinating attendance of parties, panelists and witnesses, admission of parties of witnesses into meeting space, timing breaks, managing the hearing recording, and communicating with witnesses and parties. The Hearing Facilitator will be present for all or part of the hearing, as needed, but will not attend or participate in the Hearing Panel’s deliberations.

Hearing Panel: appointed by the Title IX Coordinator, or their designee, the Hearing Panel is responsible for participating in hearings, reviewing relevant evidence, and participating in deliberations to determine the findings (responsible or not responsible).

Hearing Panel Chair: appointed by the Title IX Coordinator, or their designee, the Hearing Panel Chair is responsible for hearing matters proceeding under the applicable procedures for resolution of reports of conduct within the scope of Title IX. The Hearing Panel Chair may be internal (employee of the College) or external (outside person hired by the College). The Hearing Panel Chair is responsible for facilitating hearings in compliance with state and federal laws. The Hearing Panel Chair is responsible for determining the relevance of questions, statements and/or evidence through the hearing procedure.

Investigator: appointed by the Title IX Coordinator after a Formal Complaint has been signed to meet with the parties and witnesses to conduct investigative interviews. Investigators are responsible for collecting evidence and drafting an investigative report. Investigator(s) may be internal (employees of the College), external (outside persons hired by the College), or a combination of both.

ii. Evidentiary Considerations in the Investigation:

The investigation does not consider: 1) incidents not directly related to the possible violation, unless they evidence a pattern; 2) the character of the parties; or 3) questions and evidence about the Complainant's sexual predisposition or prior sexual behavior, unless such questions and evidence about the Complainant's prior sexual behavior are offered to prove that someone other than the Respondent committed the conduct alleged by the Complainant, or if the questions and evidence concern specific incidents of the Complainant's prior sexual behavior with respect to the Respondent and are offered to prove consent.

iii. Joint Hearings:

In hearings involving more than one Respondent or in which two (2) or more Complainants have accused the same individual of substantially similar conduct, the default procedure will be to hear the allegations jointly.

However, the Title IX Coordinator may permit the investigation and/or hearings pertinent to each Respondent to be conducted separately if there is a compelling reason to do so. In joint hearings, separate determinations of responsibility will be made for each Respondent with respect to each alleged policy violation.

iv. Recording Hearings:

Hearings (but not deliberations) are recorded by the College for purposes of review in the event of an appeal. The parties may not record the proceedings and no other unauthorized recordings are permitted.

The Hearing Panel, the parties, their Advisors, and appropriate administrators of the College will be permitted to listen to or watch the recording in a controlled environment determined by the Title IX Coordinator. No person will be given or be allowed to make a copy of the

recording without permission of the Title IX Coordinator.

v. Standard of Proof:

The panel will deliberate in closed session to determine whether the Respondent is responsible or not responsible for the policy violation(s) in question. A majority vote is required to determine the finding. The preponderance of the evidence standard of proof is used.

### ***Sanction Guidelines***

Any student found responsible for violating the policy provisions on sexual harassment will receive a sanction up to and including expulsion, depending on the severity of the incident and taking into account any prior disciplinary history and other relevant factors. Potential sanctions for violation of the policy include but are not limited to: disciplinary probation, loss of privileges, relocation of residence, restriction from facilities or activities, temporary or permanent residence hall suspension, mandated assessment and/or counseling, educational project, withholding of degree, suspension and/or expulsion.

For those crimes of violence that the College is required by federal law to include in this Annual Security Report, the transcripts of suspended or expelled students found responsible after a hearing and appeal, if any, shall include the notation, “suspended after a finding of responsibility for a code of conduct violation” or “expelled after a finding of responsibility for a code of conduct violation”. An appeal in writing may be submitted to the Vice President of Student Affairs seeking removal of a transcript notation for a suspension, provided that such notation shall not be removed prior to one year after conclusion of the suspension. While notations for expulsion shall not be removed, if a finding of responsibility is vacated for any reason, any such transcript notation shall be removed. If a student withdraws while subject to a complaint, investigation or charges based upon alleged conduct constituting a crime of violence that the College is required by federal law to include in this Annual Security Report, the transcript of the student shall include the notation, “withdrew with conduct charges pending”.

### ***New York State’s Student Bill of Rights***

The rights listed below are provided under New York State Education Law Article 129-B and are afforded to all students reporting sexual assault, domestic violence, dating violence or stalking, as well as all students accused of such offenses, regardless of race, color, national origin, religion, creed, age, disability, sex, gender identity or expression, sexual orientation, familial status, pregnancy, predisposing genetic characteristics, military status, status as a domestic violence victim, or criminal conviction. All students have the right to:

1. Make a report to local law enforcement and/or state police;
2. Have disclosures of domestic violence, dating violence, stalking, and sexual assault treated seriously;
3. Make a decision about whether or not to disclose a crime or violation and participate in the judicial or conduct process and/or criminal justice process free from pressure by the institution;

4. Participate in a process that is fair, impartial, and provides adequate notice and a meaningful opportunity to be heard;
5. Be treated with dignity and to receive from the institution courteous, fair, and respectful health care and counseling services, where available;
6. Be free from any suggestion that the reporting individual is at fault when these crimes and violations are committed, or should have acted in a different manner to avoid such crimes or violations;
7. Describe the incident to as few institution representatives as practicable and not be required to unnecessarily repeat a description of the incident;
8. Be protected from retaliation by the institution, any student, the accused and/or the respondent, and/or their friends, family and acquaintances within the jurisdiction of the institution;
9. Access to at least one level of appeal of a determination;
10. Be accompanied by an advisor of choice who may assist and advise a reporting individual, accused, or respondent throughout the judicial or conduct process including during all meetings and hearings related to such process; and
11. Exercise civil rights and practice of religion without interference by the investigative, criminal justice, or judicial or conduct process of the institution.

## **OTHER PROVISIONS**

1. **Amnesty for Minor Violations:** The health and safety of every student at the College is of utmost importance. Union College recognizes that students who have been drinking and/or using drugs (whether such use is voluntary or involuntary) at the time that violence, including but not limited to domestic violence, dating violence, stalking, or sexual assault occurs may be hesitant to report such incidents due to fear of potential consequences for their own conduct. Union College strongly encourages students to report domestic violence, dating violence, stalking, or sexual assault to institution officials. A bystander acting in good faith or a reporting individual acting in good faith that discloses any incident of domestic violence, dating violence, stalking, or sexual assault to Union College officials or law enforcement will not be subject to Union College's code of conduct action for violations of alcohol and/or drug use policies occurring at or near the time of the commission of the domestic violence, dating violence, stalking, or sexual assault.

2. **Attendance Expectations:** If an individual chooses not to attend one or more meetings or proceedings during the process, the allegations will be reviewed on the basis of the information and evidence available, and a decision will be made. Although no inference may be drawn against a student for failing to attend a meeting or remaining silent, the process will proceed and the conclusion will be based on the evidence presented. No decision shall be based solely on the failure of a party to attend one or more meetings, to participate in such meeting(s), or to answer the allegations.

## ***Title IX Complaints and Criminal Proceedings***

### REPORTING TO LAW ENFORCEMENT

1. Criminal reports may be made as follows:

- In an emergency, call 911,
- For non-emergency reporting call the Union College Campus Safety Department at 518-388-6911, or
- Contacting local police in the city where the misconduct took place.

2. The College will not notify law enforcement when it receives a report of conduct prohibited by Title IX unless:

- A primary party of the report is a minor, and such report is required by law and the alleged
- conduct is of a criminal nature;
- The reported conduct is of a violent and ongoing nature, putting the entire community at risk; or
- The Complainant, in reporting an allegation to the College, requests that a copy of the report be shared with law enforcement.

A person filing a Title IX complaint may elect to go through the process for addressing conduct prohibited by Title IX as outlined in College Policy, file a report with law enforcement independently, or engage in both processes, either in succession or simultaneously. When someone chooses to engage in a formal Title IX investigation at the College, that person cannot be required or compelled to report to law enforcement. The College recognizes that the decision to go through one or both processes is highly personal and can be difficult. The College Campus Safety Department will work to communicate ongoing processes for those engaged in a criminal complaint, and support measures will be offered by the College to all students involved in a criminal matter, as necessary, even when the matter is not being pursued through the College policy.

### **Anonymous Reporting**

Any individual may make an anonymous report concerning an act of sexual misconduct, relationship violence, sexual harassment, or stalking. An individual may report the incident without disclosing his/her name, identifying the respondent or requesting any action. Depending on the extent of information available about the incident or the individuals involved, however, the College's ability to respond to an anonymous report may be limited. The form must be submitted to Campus Safety or the Title IX Coordinator, who will determine any appropriate steps, including individual or community remedies as

appropriate, and in consultation with the Director of Campus Safety, compliance with all Clery Act obligations.

### **Preservation of Evidence**

As time passes, evidence may dissipate or become lost or unavailable, thereby making investigation, possible prosecution, disciplinary proceedings, or obtaining protection from abuse orders related to the incident more difficult. If a victim chooses not to make a complaint regarding an incident, he or she nevertheless should consider speaking with Campus Public Safety or other law enforcement to preserve evidence in the event that the victim changes her/his mind at a later date.

### **Report Intake**

Reports of domestic violence, dating violence, sexual assault or stalking that are received by College employees are referred to the Title IX Coordinator. The Title IX Coordinator, or their designee, will facilitate an intake with the complaining party to assess immediate mental and physical health and well-being, providing the reporting party with applicable resources, including on and off-campus resources. The Title IX Coordinator will review with the reporting party their right to pursue criminal charges, and will refer, if requested, the party to the New York State Police Campus Sexual Assault Unit and/or local police. If the accused in the report received is a member of the Union College community, the Title IX Coordinator will assess the report to determine the applicable policy and correlating procedures.

If the report is determined to be conduct within the scope of Title IX the applicable policies can be found on the [Title IX policies and procedures page](#). Separate policies exist for students, faculty, and staff.

If the accused is not a member of the Union College community, reporting parties shall be referred to applicable state and/or local police, community safety, and wellness resources. The College may also address the report to the extent practicable under the circumstances.

### ***Assistance for Victims: Rights & Options***

Regardless of whether a victim elects to pursue a criminal complaint or whether the offense is alleged to have occurred on or off campus, the College will assist victims of sexual assault, domestic violence, dating violence, and stalking and will provide each victim with a written explanation of their rights and options. In New York State, a victim of domestic violence, dating violence, sexual assault or stalking has the following rights & options.

In order to facilitate domestic violence victims' access to protective and prosecutorial resources, New York family courts and criminal courts have concurrent jurisdiction over "family offenses" such as assault, sexual misconduct or abuse, stalking, menacing, and strangulation. As a result, victims of domestic violence may bring civil charges in family court, criminal charges in criminal court, or simultaneous actions in both courts. Victims may also apply for an order of

protection from either court, including an order that the defendant stay away from the victim and the children involved.

Although New York criminal law does not differentiate between domestic-violence related crimes and other offenses, it nonetheless criminalizes several violent acts which may occur between spouses, former spouses, parent and child, or members of the same household in an intimate relationship. An aggressor may be convicted of assault depending on the physical harm he or she intends to inflict as well as the actual harm suffered by the victim. One form of first-degree assault occurs when the aggressor intends to cause serious physical injury to another person and does injure the intended victim or a third person using a deadly weapon or dangerous instrument. Third-degree assault occurs when the aggressor (a) intends to cause physical injury to another person and injures either the intended victim or a third person; (b) recklessly causes injury to another person; or (c) with criminal negligence, causes physical injury to another person using a deadly weapon or dangerous instrument.

New York also criminalizes stalking, which occurs when an aggressor intentionally and for no legitimate purpose engages in a course of conduct directed at the victim while knowing that his or her conduct is likely to cause or does cause material harm to the victim's mental or emotional health; a reasonable fear of material harm to the victim's physical health, safety or property or that of the victim's immediate family; or a reasonable fear that the victim's employment, business or career is threatened.

Menacing is another prohibited crime. An aggressor engages in menacing when he or she intentionally places - or attempts to place - another person in reasonable fear of physical injury or death by displaying a deadly weapon or dangerous instrument; or repeatedly follows the victim, engages in a course of conduct, or commits acts over a period of time that are intended to place the victim in reasonable fear of physical injury or death. The crimes of strangulation - described as the criminal obstruction of breathing or blood circulation resulting in the victim's physical or serious physical injury - and the lesser offense of criminal obstruction of breathing or blood circulation are also punishable by law. -

Further, Union College complies with New York State law in recognizing orders of protection. Any person who obtains an order of protection should provide a copy to Campus Safety and the Office of the Title IX Coordinator. A complainant may then meet with Campus Safety to develop a Safety Action Plan, which is a plan for Campus Safety and the victim to reduce risk of harm while on campus or coming and going from campus. This plan may include, but is not limited to: escorts, special parking arrangements, providing a temporary cell phone, or changing classroom location.

The College cannot apply for a legal order of protection, no contact order or restraining order for a victim from the applicable jurisdiction(s). The victim is required to apply directly for these services. Protection from abuse orders may be available through Schenectady City Court or



Family Court with an originating arrest and a report to the Schenectady Police Department.

The College may issue an institutional no contact order if deemed appropriate or at the request of the victim or accused. To the extent of the victim’s cooperation and consent, College offices will work cooperatively to ensure that the complainant's health, physical safety, work and academic status are protected, pending the outcome of a formal College investigation of the complaint. For example, if reasonably available, a complainant may be offered changes to academic, living, or working situations in addition to counseling, health services, visa and immigration assistance and assistance in notifying appropriate local law enforcement. Additionally, personally identifiable information about the victim will be treated as confidential and only shared with persons with a specific need to know who are investigating/adjudicating the complaint or delivering resources or support services to the complainant (for example, publicly available record-keeping for purposes of Clery Act reporting and disclosures will be made without inclusion of identifying information about the victim). Further, the College will remain as confidential any accommodations or supportive measures provided to the victim to the extent that maintaining such confidentiality would not impair the ability of the institution to provide the accommodations or supportive measures.

The College does not publish the names of crime victims nor house identifiable information regarding victims in the Campus Safety Department’s Daily Crime Log. Victims may request that directory information on file be removed from public sources by request to Thomas Constantine, Director of Campus Safety.

### ***How to be an Active Bystander***

Bystanders play a critical role in the prevention of sexual and relationship violence. They are “individuals who observe violence or witness the conditions that perpetuate violence. They are not directly involved but have the choice to intervene, speak up, or do something about it”.<sup>3</sup> We want to promote a culture of community accountability where bystanders are actively engaged in the prevention of violence without causing further harm. We may not always know what to do even if we want to help. Below is a list<sup>4</sup> of some ways to be an active bystander. If you or

someone else is in immediate danger, dial 911. This could be when a person is yelling at or being physically abusive towards another and it is not safe for you to interrupt.

### ***Tips for intervening***

In a situation potentially involving sexual assault, relationship violence, or stalking:

- Approach everyone as a friend
- Do not be antagonistic
- Avoid using violence
- Be honest and direct whenever possible
- Recruit help if necessary
- Keep yourself safe
- If things get out of hand or become too serious, contact the police

### ***The Bystander Intervention Playbook***

These tips may be useful.

- **Defensive Split** - Step in and separate two people. Let them know your concerns and reasons for intervening. Be a friend and let them know you are acting in their best interest. Make sure each person makes it home safely
- **Pick and Roll** - Use a distraction to redirect the focus somewhere else: “Hey, I need to talk to you.” or “Hey, this party is lame. Let’s go somewhere else.”
- **The Option** - Evaluate the situation and people involved to determine your best move. You could directly intervene yourself, or alert friends of each person to come in and help. If the person reacts badly, try a different approach.
- **Full Court Press** - Recruit the help of friends of both people to step in as a group.
- **Fumblerooski** - Divert the attention of one person away from the other person. Have someone standing by to redirect the other person’s focus (see Pick and Roll). Commit a party foul (i.e. spilling your drink) if you need to.

### ***Risk Reduction***

With no intent to victim blame and recognizing that only rapists are responsible for rape, the following are some strategies to reduce one’s risk of sexual assault or harassment (taken from Rape, Abuse, & Incest National Network, [www.rainn.org](http://www.rainn.org))

1. Be aware of your surroundings. Knowing where you are and who is around you may help you to find a way to get out of a bad situation.
2. Try to avoid isolated areas. It is more difficult to get help if no one is around.
3. Walk with purpose. Even if you don’t know where you are going, act like you do.
4. Trust your instincts. If a situation or location feels unsafe or uncomfortable, it probably isn’t the best place to be.

5. Try not to load yourself down with packages or bags as this can make you appear more vulnerable.
6. Make sure your cell phone is with you and charged and that you have cab money. 7. Don't allow yourself to be isolated with someone you don't trust or someone you don't know.
7. Avoid putting music headphones in both ears so that you can be more aware of your surroundings, especially if you are walking alone.
8. When you go to a social gathering, go with a group of friends. Arrive together, check in with each other throughout the evening, and leave together. Knowing where you are and who is around you may help you to find a way out of a bad situation.
9. Trust your instincts. If you feel unsafe in any situation, go with your gut. If you see something suspicious, contact law enforcement immediately (local authorities can be reached by calling 911 in most areas of the U.S.).
10. Don't leave your drink unattended while talking, dancing, using the restroom, or making a phone call. If you've left your drink alone, just get a new one.
11. Don't accept drinks from people you don't know or trust. If you choose to accept a drink, go with the person to the bar to order it, watch it being poured, and carry it yourself. At parties, don't drink from the punch bowls or other large, common open containers.
12. Watch out for your friends, and vice versa. If a friend seems out of it, is way too intoxicated for the amount of alcohol they've had, or is acting out of character, get him or her to a safe place immediately.
13. If you suspect you or a friend has been drugged, contact law enforcement immediately (local authorities can be reached by calling 911 in most areas of the U.S.). Be explicit with doctors so they can give you the correct tests (you will need a urine test and possibly others).
14. If you need to get out of an uncomfortable or scary situation here are some things that you can try:
  - a. Remember that being in this situation is not your fault. You did not do anything wrong, it is the person who is making you uncomfortable that is to blame.
  - b. Be true to yourself. Don't feel obligated to do anything you don't want to do.
  - c. "I don't want to" is always a good enough reason. Do what feels right to you and what you are comfortable with.
  - d. Have a code word with your friends or family so that if you don't feel comfortable you can call them and communicate your discomfort without the person you are with knowing. Your friends or family can then come to get you or make up an excuse for you to leave.
  - e. Lie. If you don't want to hurt the person's feelings it is better to lie and make up a reason to leave than to stay and be uncomfortable, scared, or worse. Some excuses you could use are: needing to take care of a friend or family member, not feeling well, having somewhere else that you need to be, etc.
15. Try to think of an escape route. How would you try to get out of the room? Where are the doors? Windows? Are there people around who might be able to help you? Is there an emergency phone nearby?
16. If you and/or the other person have been drinking, you can say that you would rather

wait until you both have your full judgment before doing anything you may regret later.

## ***Adjudication of Violations***

When a Responsible Employee at Union College becomes aware of an incident of domestic violence, dating violence, sexual assault, or stalking, it is reported to the Title IX Coordinator regardless of the reporting party's intention or wish to pursue criminal charges. In compliance with New York State Education Law 129-B, the Title IX coordinator reviews the reporting party's rights to pursue criminal and/or institutional processes.

### **Students**

The Title IX Policy governs all members of the Union College community for conduct defined as Title IX sexual harassment. This policy and its associated procedures will be utilized if the Title IX Coordinator determines that the conduct reported falls within its scope. The Title IX Policy is in compliance with Title IX of the 1972 of the Education Amendments. The jurisdiction of this policy encompasses all forms of Title IX sexual harassment which occur on Union College's campus or property.

The Gender-based Misconduct Policy governs reports of gender-based misconduct by students as defined by state and federal law as well as conduct the Union College community has deemed inconsistent with its community standards. This policy and its associated procedures will be utilized if the Title IX Coordinator determines that the conduct reported falls within its scope.

The Gender-based Misconduct Policy has jurisdiction over misconduct which occurs on and off campus, including during Union College sanctioned travel or study abroad and off-campus housing, if such conduct affects the reporting party on-campus.

The **Policy Prohibiting Discrimination, Harassment, Bias and Retaliation in Employment** governs all employees of the Union College. This policy and its associated procedures will be utilized if the Title IX Coordinator & Equal Opportunity Specialist determines that the conduct reported falls within its scope. The Policy Prohibiting Discrimination, Harassment, Bias and Retaliation in Employment is in compliance with state and federal nondiscrimination and equal opportunity laws. It includes procedures for the adjudication of matters within its jurisdiction, can be found at the following link:

All reports of sexual harassment that are brought against an employee, whether reported under the Title IX Policy or under the Policy Prohibiting Discrimination, Harassment and Retaliation in Employment will be reviewed by the Title IX Coordinator & Equal Opportunity Specialist or designee and the Associate Director of HR Compliance & Training to determine whether the conduct alleged falls under the Title IX Policy, the College's Policy Prohibiting Discrimination, Harassment and Retaliation in Employment and/or other College policies.

To the extent that alleged prohibited conduct falls outside its Title IX procedures, or misconduct falling outside the Title IX procedures is discovered in the course of investigating prohibited conduct covered by the procedures, the College retains authority to investigate and adjudicate the allegations under the Title IX procedures or under the procedures set forth in the Policy Prohibiting Discrimination, Harassment and Retaliation in Employment or other applicable College policies or procedures through a separate grievance proceeding.

## ***Confidentiality***

The College will protect the identity of persons who report having been victims of sexual assault, domestic violence, dating violence, or stalking to the fullest extent of the law and as

previously mentioned in this document.

**Timely Warning.** If a report of misconduct indicates the existence of a serious or continuing threat to the Union College community, the College may be required to issue a campus wide timely warning (which can take the form of an email to campus) to protect the health or safety of the community. The timely warning will not include identifying information about the Reporting Party.

All College proceedings are conducted in good faith compliance with the requirements of FERPA, the Clery Act, Title IX, Article 129-B of the New York State Education Law, and other federal laws. No information shall be released from such proceedings except as required or permitted by law and College policy.

### ***Training of Adjudicators***

The Violence Against Women Act amendments to the Clery Act require that certain College officials charged with responding to sexual assault, domestic violence, dating violence, and stalking be trained annually in a number of areas. Union College is a member of several professional and developmental organizations including the SUNY Student Conduct Institute. As part of the membership, covered officials who investigate or conduct proceedings to address allegations of dating violence, domestic violence, sexual assault and stalking receive at least eight hours of training annually through attendance at the SUNY Student Conduct Institute's Basic Compliance Training and/or live Advanced Trainings and/or digital Basic or Advanced Trainings. These in-person and digital courses address topics including how to determine the relevancy of evidence and use it during the proceeding, proper techniques for questioning witnesses, basic procedural rules for conducting a proceeding, and avoiding actual and perceived conflicts of interest. These trainings also address how to conduct an investigation and hearing process that protects the safety of victims, properly employs trauma-informed practice, and promotes accountability, while protecting the due process rights of the respondent. Finally, these trainings provide comprehensive reviews of federal and state laws and regulations on point as well as relevant court and administrative opinions.

Additionally, Union College is a member of Student Affairs Administrators in Higher Education (NASPA). Through NASPA the College's Title IX coordinator completed a 31-hour certification. This track covered the requirements under the Department of Education's regulations for hearing proceedings; an overview of informal resolution options; and the development of policies, procedures, and practice that are compliant with the regulations. The adjudication panel chairs who facilitate hearings on alleged acts of dating violence, domestic violence, sexual assault and stalking completed a 20-hour certification. This track covered the development of policies, procedures, and practices that comply with the new regulations; Title IX hearing proceedings; evidentiary standards; and informal resolution as well as the adjudication of sexual misconduct for matters not governed by the Title IX Policy. The Title IX investigators completed a 12-hour certification which covered interview techniques, constructing a report, and evidentiary standards used in Title IX cases.

## ***Sanctions and Supportive Measures***

### **Sanctions**

For cases in which a respondent is found responsible for violating College Policy with respect to sexual misconduct (including but limited to sexual assault, domestic violence, dating violence or stalking), appropriate disciplinary sanctions will be imposed. These may include, but are not limited to, one or more of the following:

- Educational Sanctions
- Interim Restrictions
- Loss of Privileges
- Denial of specified privileges for a designated period of time.
- Physical Restrictions
- Probation
- Residence Reassignment
- Residence Termination
- Suspension
- Suspension with Academic Delay
- Expulsion
- Withholding the Granting of a Degree or Revocation of a Degree

### **Supportive Measures**

The College may implement supportive measures following a report of sexual misconduct, including but not limited to domestic violence, dating violence, sexual assault and/or stalking, which may include some or all of the actions described below:

The Dean of Students (or designee), regardless of whether the complainant wishes to pursue a formal or informal resolution or no resolution, may issue a “no contact” directive.

A “no contact” directive typically will include a directive that the parties refrain from having contact with one another, directly or through proxies, whether in person or via electronic means, for a specified period of time or indefinitely (e.g., pending the investigation and/or, the hearing, if applicable). The Dean of Students (or designee) shall make the “no contact” directive available to the parties as soon as it is issued. In the event the Dean of Students (or designee) is notified of a violation of the terms of a “no contact” directive, the party in alleged violation of the “no contact” directive shall be provided an opportunity to review the matter with the Dean of Students (or designee).

If the Dean of Students (or designee), based upon the information available, decides that the “no contact” directive has been violated, the Dean of Students (or designee) may suspend the party temporarily pending the resolution of the underlying complaint. The Dean of Students (or designee) may also take further protective action that he/she deems appropriate concerning the interaction of the parties pending the hearing, if any, including without limitation directing the



Dean of Studies to alter the student's academic schedule and/or the Director of Campus Housing to alter the student's housing.

The Title IX Coordinator or their designee will also determine whether other supportive measures should be implemented, and, if so, take steps to implement those supportive measures as soon as possible. Examples of supportive measures include, but are not limited to: a College order of no contact, residence hall relocation, adjustment of course schedules, a leave of absence, or reassignment to a different supervisor or position. These remedies may be applied to one, both, or multiple parties involved. Violations of the Title IX Coordinator's directives and/or supportive measures will constitute related violations that may lead to additional disciplinary action. Supportive measures imposed may be temporary pending the results of an investigation or may become permanent as determined by Union College.

Student parties may petition the Vice President for Student Affairs and Dean of Students, in writing, to review the Title IX Coordinator's decision whether to issue, modify or remove supportive measures. A party may seek such review only if the supportive measure directly impacts that party. The Title IX Coordinator will inform the non-petitioning party that a request has been filed and provide a copy of the request to that party. If, based upon the request, the Vice President for Student Affairs and Dean of Students is considering issuing, modifying, or removing a supportive measure, the Vice President for Student Affairs and Dean of Students will invite the non-petitioning party and the Title IX Coordinator to submit responses. If the Vice President for Student Affairs and Dean of Students determines that the Title IX Coordinator's decision should be set aside, the Vice President for Student Affairs and Dean of Students will instruct the Title IX Coordinator to vacate the prior decision on supportive measures immediately. At that time, the Title IX Coordinator may impose alternate reasonable and appropriate supportive measures. The Vice President for Student Affairs and Dean of Students may, but is not required to, provide the Title IX Coordinator with guidance regarding appropriate alternate supportive measures.

### **Emergency Removal or Interim Suspension**

The College may remove a student respondent from the College's program or activity on an emergency basis, where the College: (1) undertakes an individualized safety and risk analysis; and (2) determines that an immediate threat to the physical health or safety of any student or other individual arising from the allegations of conduct within the scope of Title IX justifies a removal. In addition, where a report of sexual misconduct outside the scope of Title IX poses an ongoing risk of harm to the safety or well-being of an individual or members of the campus community, the College may place an individual or organization on interim suspension.

A party will be given notice and a prompt opportunity for reconsideration of the need for and terms of an emergency removal or interim suspension by the Vice President for Student Affairs and Dean of Students, and to submit evidence in support of such request. If, based upon the request, the Vice President for Student Affairs and Dean of Students is considering modifying, or lifting the emergency removal or interim suspension, the Vice President for Student Affairs and Dean of Students will invite the non-petitioning party and the Title IX Coordinator to submit responses.

The emergency removal and interim suspension processes apply only to student respondents. Employee respondents are not subject to this process and may be placed on administrative leave pursuant to the College's applicable policies and/or collective bargaining agreements.

### **Disclosure of Results**

The College will, upon written request, disclose to the alleged victim of a crime of violence, or a non-forcible sex offense, the report on the results of any disciplinary proceeding conducted by the College against a student who is the alleged perpetrator of such crime or offense. If the alleged victim is deceased as the result of such crime or offense, the next of kin of such victim shall be treated as the alleged victim for purposes of this paragraph.

### ***Sex Offender Registration***

The federal Campus Sex Crimes Prevention Act, enacted on October 28, 2000 (also known as the Jacob Wetterling Act), requires institutions of higher education to issue a statement advising the campus community where law enforcement agency information provided by a State concerning registered sex offenders may be obtained. It also requires sex offenders already required to register in a State to provide notice, as required under State law, of each institution of higher education in that State at which the person is employed, carries on a vocation, volunteers services or is a student.

- Callers must have an individual's name and one of the following – an exact address, date of birth, driver's license number, or Social Security number – to learn if the individual is on the Registry.

The Schenectady Police Department may also provide Sex Offender Registry Information – Our SPD contact is the Detective Division, reached at 518-382-5245.

### ***Sexual Health Programs and Policies***

The College engages in comprehensive, intentional, and integrated programming, initiatives, strategies, and education campaigns intended to end dating violence, domestic violence, sexual assault and stalking that:

- Are culturally relevant, inclusive of diverse communities and identities, sustainable, responsive to community needs, and informed by research, or assessed for value, effectiveness, or outcome; and
- Consider environmental risk and protective factors as they occur on the individual, relationship, institutional, community and societal levels.

Educational programming consists of primary prevention and awareness programs for all incoming students and new employees and ongoing awareness and prevention campaigns for students and employees that:

- Identifies domestic violence, dating violence, sexual assault and stalking as prohibited conduct;
- Defines, using definitions provided by both federal and New York State law, what behavior constitutes domestic violence, dating violence, sexual assault, and stalking;
- Defines what behavior and actions constitute consent to sexual activity in New York State and using the definition of consent found in College policy, including the Policy Prohibiting Discrimination, Harassment, Bias and Retaliation, the Title IX Policy and Procedures, and the Student Code of Conduct;
- Provides a description of safe and positive options for bystander intervention. Bystander intervention means safe and positive options that may be carried out by an individual or individuals to prevent harm or intervene when there is a risk of dating violence, domestic violence, sexual assault or stalking. Bystander intervention includes recognizing situations of potential harm, understanding institutional structures and cultural conditions that facilitate violence, overcoming barriers to intervening, identifying safe and effective intervention options, and taking action to intervene;
- Information on risk reduction. Risk reduction means options designed to decrease perpetration and bystander inaction and to increase empowerment for victims in order to promote safety and to help individuals and communities address conditions that facilitate violence.
- Information regarding:
  - procedures victims should follow if a crime of domestic violence, dating violence, sexual assault or stalking occurs;
  - how the institution will protect the confidentiality of victims and other necessary parties;
  - existing counseling, health, mental health, victim advocacy, legal assistance, visa and immigration assistance, student financial aid, and other services available for victims, both within the institution and in the community;
  - options for, available assistance in, and how to request changes to academic, living, transportation, and working situations or protective; and
  - procedures for institutional disciplinary action in cases of alleged dating violence, domestic violence, sexual assault, or stalking.

The College has developed a robust, annual educational campaign consisting of presentations that include educational materials for new students; participating in and presenting information and materials during new employee onboarding; and ongoing activities, programs and awareness initiatives to all employees and students. ## ***Violence and Intervention***

### **Union College Sexual Assault/Misconduct Policy:**

The Union College administration offers programs and services that promote a balance of physical, emotional, social, intellectual and spiritual health. It encourages students to respect the dignity and rights of others, while developing a strong sense of their personal self-esteem and development. This includes building healthy sexual relationships, developing communication skills and reducing interpersonal violence.

### ***Scope of Policy***

The College strongly encourages all members of our community to take action to maintain and facilitate a safe, welcoming and respectful environment on campus. In particular, the College expects that all Union community members will take reasonable and prudent actions to prevent or stop sexual misconduct.

When used below, “reporting party” refers to the individual who is identified as the recipient of prohibited conduct. “Responding party” refers to the individual alleged to have engaged in

prohibited conduct. A “Third-Party” refers to any other participant in the process, including a witness or an individual who makes a report on behalf of a Reporting Party.

### ***Persons Covered***

Union College’s policies with respect to sexual misconduct collectively apply to all Union community members including students, faculty, administrators, staff, volunteers, vendors, contractors, visitors, and individuals paid or unpaid, regularly or temporarily employed, interns, conducting business, studying, living, visiting, or having any official capacity with the College or on its property (collectively referred to as "any person covered").

The College strongly encourages reports of sexual misconduct regardless of who engaged in the conduct. Even if the College does not have jurisdiction over the responding party, the College will take prompt action to provide for the safety and well-being of the reporting party and the broader campus community.

### ***Locations Covered***

College policies apply to conduct that occurs on any part of Union’s campus or property as well as when students, staff, or faculty travel off-campus as part of a College activity, team, organization, event, or College sponsored study abroad programs.

College policy also covers conduct that occurs off-campus, in the City, and/or during a time when the College is not in session when the behavior impacts the campus environment (as would be the case, for example, if one student sexually assaults another student in an off-campus apartment or overseas during a term abroad, or if a student sends another student lewd and threatening sexual emails while at home during the term break). The Title IX Coordinator will consult with the Dean of Students in making this determination. In understanding this aspect of Union’s expectations for student behavior, it may be helpful to think of student status as “portable” and therefore operative even when students are not on Union’s campus or property.

Similarly, for staff and faculty, College policy covers conduct that takes place off campus when it impacts the work environment. In making this determination, the Title IX Coordinator or appropriate administrator will consider whether the alleged action took place during a Union College sponsored event or activity, used College property in a way to commit the alleged action, or affects the employment relationship. For example, an email or communication from a home computer or behavior that takes place off campus between employees that affects the employment relationship may be considered a potential violation.

A reporting party is encouraged to report misconduct regardless of where the incident occurred or who committed it. Even if the College does not have jurisdiction over the responding party, the College will still take prompt action to provide for the safety and well-being of the reporting party and the broader community.

### ***Filing a Complaint***

The College recognizes that deciding whether or not to make a report, either to the College or law enforcement, and choosing how to proceed can be difficult decisions. Below is information related to making a report that may be helpful to consider:

- Making a report means telling someone in authority what happened -- in person, by telephone, in writing, or by email.
- Making a report does not automatically trigger the College's formal grievance procedures. In response to a report, the College will provide support that can assist individuals in deciding how to proceed. To the extent legally possible, the College will respect the wishes of the reporting party regarding how and if to move forward.
- Under certain circumstances, however, the College will have to move forward. These circumstances are limited to when the College has weighed the request for confidentiality or not to proceed under the College's formal grievance procedures against factors such as the seriousness of the alleged misconduct, the risk that the responding party will commit additional acts of misconduct, the respective ages and positions of the reporting party and responding party, whether there have been other complaints against the responding party, whether the responding party has a history of arrests or records from a prior school indicating a history of comparable violence, whether the responding party allegedly threatened further sexual misconduct or other violence against the reporting party or others, whether the misconduct was allegedly committed by multiple responding parties, whether the misconduct allegedly involved the use of a weapon, whether the reporting party is under 18 years of age, whether the College possesses other means to obtain relevant evidence of the alleged misconduct (e.g., security cameras, physical evidence), and whether the report reveals a potential pattern of misconduct (e.g., via illicit use of drugs or alcohol, at a particular location or by a particular group)
- The health and safety of every student at Union College is of utmost importance, therefore, the College provides amnesty for alcohol or other drug use by students in the course of an incident of sexual misconduct. The College recognizes that students who have been drinking alcohol and/or using other drugs (whether such use is voluntary or involuntary) at the time that sexual misconduct occurs may be hesitant to report such incidents due to fear of potential consequences for their conduct. Union College strongly encourages students to report sexual misconduct to College officials. A bystander acting in good faith or a reporting individual acting in good faith that discloses any incident of sexual misconduct to College officials or law enforcement will not

be subject to Union College's Code of Conduct action for violations of alcohol and/or other drug use policies occurring at or near the time of the sexual misconduct incident.

- The College will not tolerate intentional false reporting of incidents. The College takes the accuracy of information very seriously as a charge of sexual misconduct may have severe consequences. A good-faith complaint that results in a finding of not responsible is not considered a false or fabricated accusation of sexual misconduct. However, when a reporting party or third party witness is found to have fabricated allegations or given false information with malicious intent or in bad faith, the reporting party or third party witness may be subject to disciplinary action. It is a violation of the Code of Student Conduct to make an intentionally false report of any policy violation, and it may also violate state criminal statutes and civil defamation laws.

All covered persons shall have the right to emergency access to the Title IX Coordinator or other trained official who shall be available upon the first instance of disclosure by a reporting party to provide information regarding options to proceed and, where applicable, the importance of preserving evidence and obtaining a sexual assault forensic examination as soon as possible, and detailing that the criminal justice process utilizes different standards of proof and evidence and that any questions about whether a specific incident violated the penal law should be addressed to law enforcement or to the district attorney. The official will also explain whether they are authorized to offer the reporting individual confidentiality or privacy, and will inform the reporting individual of other reporting options as well as other pertinent information.

If the accused is an employee of the College, the reporting party shall have the right to report the incident to the College's Human Resources Department or may request that a confidential or private employee assist in reporting to the appropriate human resources authority.

Reporting parties also have the right to receive assistance from appropriate institution representatives in initiating legal proceedings in family court or civil court.

The specific procedures for investigating, and resolving alleged sexual misconduct are based upon the nature of the responding party's relationship to the College (student, staff, faculty or third party). Each set of procedures referenced below is guided by the same principles of fairness and respect for the reporting party and responding party.

The College applies the preponderance of the evidence standard when determining whether these policies have been violated. Preponderance of the evidence means that it is more likely than not that a policy violation occurred.



## ***Initial Title IX Assessment***

Unless a report is made directly to the Title IX Coordinator, reports received by the Title IX Coordinator from private reporting resources or responsible employees will result in a request by the Title IX Coordinator to meet with the reporting party. The purpose of the preliminary meeting is to gain a basic understanding of the nature and circumstances of the report in order to conduct an initial assessment; it is not intended to be a full forensic interview.

As part of the initial assessment of the report, the College will:

- Assess the nature and circumstances of the allegation.
- Address immediate physical safety and emotional well-being needs.
- Notify the complainant of his/her right to contact law enforcement and seek medical treatment, including the importance of preservation of evidence.
- Enter the report into the College's daily crime log (if applicable).
- Provide the complainant with information about:
  - On- and off-campus resources including intervention, mental health counseling, and medical services, which shall include information on whether such resources are available at no cost or for a fee.
  - Sexually transmitted infections, sexual assault forensic examinations, and resources available through the New York State Office of Victim Services (found at <https://ovs.ny.gov/help-crime-victims>)
  - The range of interim accommodations and remedies.
  - An explanation of the procedural options, including Informal Resolution and Formal Resolution and the process for filing a Formal Complaint
- Assess for pattern evidence or other similar conduct by the respondent.
- Discuss the reporting party's expressed preference for manner of resolution and any barriers to proceeding.
- Discuss the role of an Advisor and offer suggestions for obtaining one if desired.
- Explain the College's policy prohibiting retaliation.

This initial review will proceed to the point where a reasonable assessment of the safety of the individual, and of the campus community can be made.

**Timely Warning** - If a report of misconduct discloses a serious or continuing threat to the Union College community, the College may be required to issue a campus wide timely warning (which can take the form of an email to campus) to protect the health or safety of the community. The timely warning will not include identifying information about the reporting party.

All College proceedings are conducted in good faith compliance with the requirements of FERPA, the Clery Act, Title IX, Article 129-B of the New York State Education Law, and other federal laws. No information shall be released from such proceedings except as required or permitted by law and College policy.

**Coordination with Law Enforcement** - Upon receipt of a report, Campus Safety will comply with any legal requirements to notify local law enforcement if a violent felony is suspected to have occurred. To the fullest extent permitted by law, the identity of the reporting party will not be disclosed without his/her express permission being given. Physical evidence must be properly documented and stored by local law enforcement to maintain the ability for it to be presented as evidence and used in a legal case if a complaint is filed by the reporting party with local law enforcement.

The College encourages a reporting party to pursue criminal action for incidents of sexual misconduct, including sexual assault, relationship violence, sexual harassment, or stalking, that may also be crimes under New York law. The College, through Campus Safety, will assist a reporting party in making a criminal report and cooperate with law enforcement agencies if the reporting party decides to pursue the criminal process to the extent permitted by law.

The College's sexual misconduct policies may contain provisions, including definitions, burden of proof, and standards that differ from New York criminal law. A reporting party may seek recourse under College policy and/or pursue criminal action. Neither law enforcement's determination whether or not to prosecute a responding party nor the outcome of any criminal prosecution are determinative of whether a violation of College policy has occurred. Proceedings under College policies may be carried out prior to, simultaneously with, or following civil or criminal proceedings off campus.

At the request of law enforcement, the College may agree to defer its fact-gathering until after the initial stages of a criminal investigation, but the College is not obligated to make such deferral. The College will nevertheless communicate with the reporting party regarding applicable rights, procedural options, and the implementation of interim measures to assure safety and well-being. If the College defers its fact-gathering, the College will promptly resume its fact-gathering as soon as it is informed that law enforcement has completed its initial investigation or once it decides to stop deferring fact-gathering during a criminal investigation. In cases involving allegations of sexual assault, domestic violence, dating violence or stalking, delays as described in this paragraph will not exceed 10 days unless law enforcement authorities specifically request and justify a longer delay.

**Requests to File a Formal Report/Complaint** - When a reporting party wishes to file a formal complaint, the initial assessment will include review of the information gathered from the reporting party and determination by the Title IX Coordinator whether the information collected alleges a violation of the applicable policy and therefore warrants further investigation under the College's grievance procedures.

At the conclusion of the assessment, and in consultation with the reporting party, the Title IX Coordinator will determine the appropriate manner of resolution and, if appropriate, refer the report for further Investigation, Alternative Resolution or Formal Resolution.

The determination/recommendation as to how to proceed will be communicated to the reporting party in writing. Depending on the circumstances and requested resolution, the responding party may or may not be notified of the report or resolution. A responding party will be notified when the College seeks action that would impact the responding party, such as supportive measures that restrict his/her movement on campus, the initiation of an investigation after the initial assessment or the decision to request the responding party to participate in Informal Resolution.

### *Appeal Process for Students*

Under the College's student sexual misconduct procedures, each party may appeal (1) the dismissal of a formal Complaint or any included allegations; and/or (2) a determination regarding responsibility. To appeal, a party must submit their written appeal to the Title IX coordinator within ten (10) calendar days of being notified of the decision, indicating the grounds for the appeal.

The Notice of Appeal should be submitted to:

The limited grounds for appeal available are as follows:

- Procedural irregularity that affected the outcome of the matter (i.e. a failure to follow the institution's own procedures);
- New evidence that was not reasonably available at the time the determination regarding responsibility or dismissal was made, that could affect the outcome of the matter;
- The Title IX Coordinator, investigator(s), or decision-maker(s) had a conflict of interest or bias for or against an individual party, or for or against Complainants or Respondents in general, that affected the outcome of the matter;
- The sanctions or remedies are not commensurate with the injury/violation or are unjust.

The appeal statement must set forth:

- the determination(s) being appealed,
- the specific ground(s) for the appeal, and
- the facts supporting the grounds.

If a party appeals, the College will as soon as practicable notify the other party in writing of the appeal, however the time for appeal shall be offered equitably to all parties and shall not be extended for any party solely because the other party filed an appeal. Appeals will be decided by an Appeals Panel appointed by the Title IX Coordinator who will be free of conflict of interest and bias, and will not serve as investigator(s), Title IX Coordinator, or Hearing Panel Chair in the

same matter.

The Appeal Panel may affirm the decision of the Hearing Panel or sustain any of the above specified grounds for appeal, in which case the Appeal Panel may:

- reverse a finding;
- change a sanction or remedy;
- remand a case to the original Hearing Panel if possible, for a new hearing or remand a case to a newly composed Hearing Panel if there were procedural violations; or
- remand a case to the original investigator(s) if possible, for a new investigation or remand a case to a new investigator if there were procedural violations in the investigation.

If the Appeal Panel calls for the admission of new evidence, if possible, it will remand the case to the Hearing Panel from which it originated for a new hearing. Upon remand from the Appeal Panel, as necessary and possible, a Hearing Panel may remand a case to the investigator(s) from which it originated for further investigation. Outcome of appeal will be provided in writing simultaneously to both parties and include rationale for the decision.

### ***Sanctions (Faculty / Staff)***

In determining sanctions and remedies for faculty and staff under the Title IX Policy, the sanctioning body will consider:

- the severity of the prohibited conduct;
- the circumstances of the prohibited conduct;
- the impact of the prohibited conduct and sanctions and remedies on the complainant;
- the impact of the prohibited conduct and sanctions and remedies on the community;
- the impact of the prohibited conduct and sanctions and remedies on the responding party;
- prior misconduct or disciplinary record of the Respondent and any criminal convictions;
- the goals of the College's Title IX Policy and these procedures; and
- any other mitigating, aggravating, or compelling factors.

### **Discipline**

Individuals who commit such acts may be removed from the premises and may be subject to disciplinary action such as:

### **Sanctions (Staff)**

When the Respondent is a staff member or administrator, the Adjudicator may recommend one or more of the following sanctions and remedies: discussion, recommendation for counseling or mentoring, monitoring of the situation, support for self-help as well as more serious disciplinary action. These may include (but are not limited to) a verbal or written warning or letter in the personnel file for a period of time or permanently, withholding of salary increases or stipends, removal from the classroom, suspension (with or without pay) or separation from the College.

## **Sanctions (Faculty)**

When the Respondent is a faculty member, the FSP may impose one or more of the following sanctions and remedies: reduction in salary; embargo on the consideration of salary increases for a specified period of time; prohibition of proposing, through the College, some or all sponsored research or other grants for a specified period of time; censure; or dismissal. If the FSP believes that dismissal is the appropriate sanction, the FSP shall recommend the dismissal to the President, who shall accept and impose or reject the recommendation of dismissal from the FSP, or the President may impose a sanction they deem appropriate. The President shall present their decision in writing to both parties setting forth the grounds for said decision. If the Respondent is a faculty member with tenure and the President imposes the sanction of dismissal, the President will seek the approval of the Board of Trustees in accordance with the College's Bylaws and subject to the appeals provision for faculty members set forth below.

## ***Appeal Process for Employees***

Each party may appeal (1) the dismissal of a formal complaint or any included allegations; (2) a determination regarding responsibility; and/or (3) sanctions imposed. To appeal, a party must submit their written appeal within ten (10) calendar days of being notified of the decision, indicating the grounds for the appeal.

The limited grounds for appeal available are as follows:

- Procedural irregularity that affected the outcome of the matter (i.e., a failure to follow the institution's own procedures);
- New evidence that was not reasonably available at the time the determination regarding responsibility or dismissal was made and that could affect the outcome of the matter;
- The Title IX Coordinator, investigator(s), or Adjudicator(s) had a conflict of interest or bias for or against an individual party, or for or against complainants or respondents in general, that affected the outcome of the matter.
- The sanctions or remedies are not commensurate with the injury/violation or are unjust.

The appeal statement must set forth:

- the determination(s) being appealed,
- the specific ground(s) for the appeal, and
- the facts supporting the grounds.

If a party appeals, the College will as soon as practicable notify the other party in writing of the appeal; however, the time for appeal shall be offered equitably to all parties and shall not be

extended for any party solely because the other party filed an appeal. Appeals for staff will be decided by an Appeal Panel consisting of the Vice President for Finance & Administration, or their designee, and another panelist. Appeals for faculty will be decided by an Appeal Panel consisting of the Vice President for Academic Affairs, or their designee, and the Chair and Secretary of the Faculty Executive Committee (“FEC”). The Appeal Panel will not include the Adjudicator, investigators, or Title IX Coordinator.

The Appeal Panel may affirm the decision of the Adjudicator or sustain any of the above specified grounds for appeal, in which case the Appeal Panel may:

- reverse a finding;
- change a sanction or remedy;
- remand a case to the original Adjudicator if possible for a new hearing or remand a case to a newly composed Adjudicator if there were procedural violations; or
- remand a case to the original investigator if possible for a new investigation or remand a case to a new investigator if there were procedural violations in the investigation.

If the Appeal Panel calls for the admission of new evidence, if possible, it will remand the case to the Adjudicator from which it originated for a new hearing.

Upon remand from the Appeal Panel, as necessary and possible, an Adjudicator may remand a case to the investigator from which it originated for further investigation. Outcome of appeal will be provided in writing simultaneously to both parties, and include rationale for the decision.

### **Appeal of the President’s Decision of Dismissal of a faculty member**

When the Respondent is a faculty member and the sanction of dismissal is imposed by the President, the President will notify both parties, and upon request of the Respondent, shall transmit to the Board of Trustees the transcript of the case and the appeal. Both parties are permitted to present written arguments to the Board of Trustees. The Board of Trustees’ review will be based on the transcript of the case and the written argument(s). The decision of the President will either be sustained by the Board of Trustees or the Board of Trustees may make a reasoned determination for a less severe sanction or exonerate the Respondent.

### ***Concerns about the Implementation of the Title IX Policy***

The College has appointed a Title IX Coordinator to oversee all aspects of the College’s Title IX compliance efforts. An individual who believes that any aspect of the College’s Title IX policy has not been properly followed should contact the Title IX Coordinator at [518-388-6865](tel:518-388-6865) or pursue a complaint by contacting the Title IX Coordinator in accordance with the College’s Discrimination Grievance Procedures contained in the Student Handbook. Retaliation against any person who files a complaint of alleged discrimination is prohibited.

## ***Policies for Possession, Use & Sale of Alcoholic Beverages***

New York State law states that no person under the age of 21 years may possess or consume alcoholic beverages. While Union College complies with New York State Alcohol Beverage Control laws, campus policy goes beyond mere compliance by defining acceptable behavior with regard to alcohol and by placing emphasis on individual responsibility and educational awareness. Violations of the College's alcohol policy are subject to campus disciplinary action. Key points of the College alcohol policy are given below:

1. No person under the age of 21 shall possess or consume any alcoholic beverage on campus.
2. At all events where alcoholic beverages are served, non-alcoholic beverages shall also be made available throughout the event.
3. All mass-consumption containers (kegs, beer balls, containers of punch, etc.) are permitted only at sponsored College events and only in those College facilities where such containers are not banned.

### ***The ABC (Alcohol Beverage Control) Law***

The New York State ABC Law addresses the issues pertaining to those under the age of twenty-one years who possess or attempt to purchase alcoholic beverages, as well as those who assist them.

## SECTION 65.1 PROHIBITED SALE:

No person shall sell, deliver or give away or cause or permit or procure to be sold, delivered or given away any alcoholic beverage to any person, actually or apparently, under the age of twenty-one years.

To purchase alcoholic beverages, the only acceptable identifications are:

- Valid Driver's License or Non-Driver Identification Card issued by a governmental agency
- Valid Passport
- U.S. Military ID

## SECTION 65-A- PROCURING ALCOHOLIC BEVERAGES FOR PERSONS UNDER THE AGE OF TWENTY-ONE YEARS

It is a criminal offense to misrepresent the age of a person under twenty-one years to induce the sale of any alcoholic beverage.

- Penalty - \$200.00 fine and /or five days in jail

## SECTION 65-B OFFENSE FOR ONE UNDER THE AGE OF TWENTY-ONE YEARS TO PURCHASE OR ATTEMPT TO PURCHASE AN ALCOHOLIC BEVERAGE THROUGH FRAUDULENT MEANS

It is an offense for one under age of twenty-one years to purchase or attempt to purchase an alcoholic beverage through fraudulent means.

- Penalties:
  - First violation: Fine up to \$100.00, and/or up to 30 hours of community service, and/or completion of an alcohol awareness program. In addition, if a New York State driver's license was used as identification, the court may suspend your license for three months.
  - Second violation: Fine between \$50.00 and \$350.00 and/or up to 30 hours of community service, and/or completion of an alcohol awareness program. In addition, if a New York State driver's license was used as identification, the court may suspend your license for six months.
  - Third and subsequent violations: Fine between \$50.00 and \$750.00 and/or up to 30 hours of community service, and/or evaluation by an appropriate agency to determine whether the person suffers from alcoholism or alcohol abuse. In addition, if a New York State driver's license was used as identification, the court may suspend your license for one year or until you reach twenty-one.



## SECTION 65-C UNLAWFUL POSSESSION OF AN ALCOHOLIC BEVERAGE WITH INTENT TO CONSUME BY PERSONS UNDER THE AGE OF TWENTY-ONE YEARS

No person under the age of twenty-one years shall possess any alcoholic beverage with the intent to consume such beverage, subject to specified exceptions.

- Penalty – Fine up to \$50.00 and /or five days in jail, and/or up to 30 hours of community service, and/or completion of an alcohol awareness program.

### *Alcohol in Residential Spaces*

Union is primarily a community of underage students, and experience teaches that the abuse of alcohol can often interfere with the productive pursuit of a college education. Students who are under the age of 21 may not possess or consume alcohol anywhere on campus including the residential spaces. Residential spaces are defined as all College-owned and administered living units. The following actions relating to alcohol are prohibited:

- Possessing, consuming or distributing alcoholic beverages by student under the age of 21 years.
- Furnishing or selling any alcohol beverages to any person under 21 years of age.
- Possessing or consuming alcohol in any public area outside the residence halls.
- Possessing or consuming alcohol outside individual bedrooms or suites within the residence halls.
- Collecting, displaying or storing empty alcohol containers.
- Being incapacitated by alcohol or drugs whether under or over the age of 21 years.
- Possessing or consuming alcohol from common sources including, but not limited to kegs, beer balls, wine boxes, and punch bowls.
- Possessing or using a tap system or “regulator.”
- Possessing any binge-drinking device including, but not limited to, funnels or beer pong tables.
- Participating in flip cup, beer pong, or any other organized games intended for rapid personal consumption.

Students over the age of 21 are allowed alcohol in their residence. The amount of alcohol allowed for students over the age of 21 is listed as follows:

- One 12-pack (twelve 12 oz. bottles/cans) of beer, hard seltzer, cider or mead OR,
- Two 750 ml bottles of wine OR,
- One 750 ml bottle of hard alcohol.

Evidence shows the irresponsible use of hard alcohol (liquor) by Union students greatly increases the risk of harm to themselves and others. Therefore, more significant sanctions may be imposed upon any student found to have distributed hard alcohol or consumed it in excess. Students age 21

and older may possess moderate amounts of hard alcohol as set forth above.

### ***Social Events with Alcohol***

Union College recognizes that a vibrant, diverse social life is an important feature of campus life and encourages students to plan events within a framework that promotes safe, legal and responsible fun. When alcohol will be available at social events, it is the responsibility of the Event Sponsor and the Responsible Persons to comply with all requirements of New York State Law and Union College Policy. These regulations apply to all College events hosted by students.

### ***Standards of Conduct at Union College***

Individuals whose ability to reason and control their actions is impaired by excessive consumption of alcohol or unlawful use of controlled substances put their lives at risk. In addition, such students endanger the well-being and safety of others. The College maintains that inebriation and/or ignorance of applicable laws and/or College Policy governing the use of alcohol and drugs are not acceptable or justifiable excuses for impermissible, unlawful, disruptive or dangerous behavior. Such excuses do not release the individual from responsibility to the residential community and the College at large. Behavior that endangers mental and/or physical health puts lives at risk, creates the potential for legal liability, and will not be tolerated.

Students and officers of organizations who assume the role of Responsible Persons at the social events with alcohol are expected to fully comply with the requirements for hosting an event. Their failure to assume these duties and obligations in good faith, which may result in disruptive and dangerous behavior, will not be tolerated.

Students who are members of fraternal organizations will be subject to the College's Alcohol and Drug Policies in the same manner as students residing in residence halls. For more about Union College's expectations involving Social Events with Alcohol, please follow [this link](#).

Irresponsible distribution of alcohol is prohibited. Such distribution includes, but is not limited to, any occasion when the atmosphere or circumstances are such that the intended or likely outcome is either abuse of alcohol or to cause rapid or extreme intoxication. Examples of irresponsible distribution of alcohol include, but are not limited to: use of funnels, shot parties, beer pong, chugging contests, or other organized drinking games.

Empty alcohol containers represent a health hazard, and students may not possess empty alcohol containers in their rooms in the residence halls. If found, empty containers may be considered evidence of alcohol consumption.

## ***Drug Policies***

In compliance with the Drug-Free Schools and Communities Act, Union College prohibits the unlawful possession, use, or distribution of illicit drugs and alcohol on the campus or as part of any of its sponsored activities. The law requires mandatory compliance with these standards of conduct. Therefore, this statement serves notice that disciplinary sanctions, up to and including suspension/dismissal, termination of employment, prosecution, and/or referral to an appropriate rehabilitation or treatment program, will be imposed on those who violate the College's drug and alcohol policies. (Source: The Union College Student Handbook.)

On March 31, 2021, the state of New York [signed into legislation](#) the legalization of adult-use cannabis for those 21-years of age and older.

### ***What does this mean for New York state?***

Because federal laws (including the Controlled Substances Act and the Drug Free Schools and Communities Act) prohibit cannabis products at educational institutions and on the premises of other recipients of federal funds, even if otherwise permitted under state or local law, students, including students with valid medical cannabis prescriptions, are prohibited from possessing or using cannabis products on the Union College campus.

## ***Tobacco Use Policy***

All tobacco products are prohibited on Union's campus grounds and facilities. This applies to all students, employees, faculty, staff, visitors and vendors. Anyone who wishes to smoke or otherwise use tobacco products will have to go off campus; this prohibition also applies to the use of vaping products.

## ***Drug Abuse at Union College***

The Union College campus is not a sanctuary from the law in matters of illicit drug use. The unlawful use of drugs, synthetic drugs and marijuana can adversely affect the academic and personal life of the individual, and has the potential to disrupt the academic and residential community of the College.

Thus, the possession, distribution, or the use of illegal drugs, synthetic drugs and narcotics, including but not limited to amphetamines, marijuana, cocaine, heroin, and LSD and any associated paraphernalia, as well as the unlawful possession, distribution or use of prescription drugs, is strictly prohibited. Violations will result in disciplinary action which may include assigning of applicable points, campus/community services, referral to a Health Educator, suspension, or expulsion. These consequences are in addition to criminal penalties under applicable law.

## ***Weapons Possession***

Possession or use of any type of firearm or any other potentially dangerous weapon on campus is prohibited. Weapons of any kind are dangerous and have no place in a college community.

All instruments which can be construed as weapons including, but not limited to, Airsoft guns, BB guns, pellet guns, handguns, rifles, pistols, knives (blade length over 3”), bows and arrows, swords, brass knuckles, night sticks, and handcuffs may not be brought onto College property. Students wishing to bring any such property to campus for sporting purposes must register the weapon or firearm with Campus Safety and store it in the Campus Safety Office.

## ***Higher Education Opportunity Act (HEOA) Fire Safety Reporting Information***

Union College Fire Safety Compliance Office – Environmental Health & Safety

The Union College Fire Safety Compliance Office is responsible for programs related to fire safety. Fire Safety works closely with the Department of Campus Safety in obtaining its data with respect to fire alarms and actual fire conditions reported. Since Union College maintains and provides student housing, we are providing this data as required under the Higher Education Opportunity Act.

### ***Contents:***

- Number and causes of each fire on campus.
- Number of fire related incidents that resulted in treatment at a medical facility.
  - Number of fire related deaths.
- Value of property damage caused by a fire.
- Description of each campus housing facility fire safety system, including sprinkler systems.
- The number of mandatory supervised fire drills.
- Policies or rules on portable electrical appliances, smoking, open flames, evacuation procedures, and fire safety education.
- Plans for future improvements in fire safety, if necessary.
- Campus log of all campus student housing fires, including the nature, date, time and general location of each fire.
- Information provided annually to students and on the Life Safety web page as well as the student handbook.

Data pages for calendar year 2023 include fire alarm / sprinkler system data for each residence hall as well as reportable fires, causes, damages, injuries, deaths.

### ***Fire Drills***

- Union College conducts four residential and three non-residential fire drills annually. Drills are conducted within the first 10 days of each term. A table listing building fire drills appears below.
- Additional fire drills are conducted for summer classes and special events as needed.
- Documentation of such fire drills is available for review at the Fire Safety Compliance Office, located at the Integrated Science and Engineering Complex, room 183B.

## ***Union College Policies***

### **Candles / Open Flame Policy**

- All types of candles that can be burned are prohibited within all Union College buildings.
- The actual display of candles is also prohibited, regardless of use.
- Fireworks, incense and any other flame or burn devices are prohibited in Union College Residence Halls.

### **Smoking Policy**

- All areas of the College campus, all campus properties, and all campus vehicles are designated as smoke/tobacco free.
- For the purpose of this policy, smoking and tobacco use is defined as using any type of tobacco product including, but not limited to, cigarettes (commercial, handmade, or electronic), cigars, cigarillos, pipes, hookahs, vape pens, oral tobacco (spit and spitless, smokeless, chew, snuff), or any other similar smoking material or delivery device including anything that simulates smoking.

## **Evacuation Policy**

Evacuation of all Union College residences should be made in a safe and orderly fashion. The Office of Residential Education has compiled an evacuation plan for each building with respect to relocation and placement of students when an evacuation is necessary. Upon the activation of a fire alarm, the Schenectady Fire Department is notified as well as Campus Safety Officers and/or EHS Officers. Campus Safety conducts a preliminary check of the building to ensure evacuation is in progress. The Residential Education (CA) staff assists with evacuation as necessary. In the event of a suspected fire or a fire alarm, occupants should take the following actions:

- Evacuate the building promptly, assisting those who may not be able to get out.
- Shut your room door as well as doors that you pass through.
- Do not worry about your belongings. They can be replaced, you cannot.
- If the alarm has not sounded, activate a fire alarm pull station.
- Know your exits and always two ways out.

## **Education/Training:**

At the beginning of the academic year, the student CA staff and Greek/Minerva staff are provided a 3 hour training program that is sponsored by the New York State Office of Fire Prevention and Control and the Union College Fire Safety Compliance Office. Students are provided with the basics of fire safety and what to do in an actual emergency condition. Throughout the course of the academic year, the EHS Office offers various types of training programs as well as a newsletter related to fire safety. Faculty and Staff are provided various levels of training with respect to fire, workplace, lab and radiation safety. Facilities personnel are provided with more advanced training geared to specific job functions.

## **Fire Safety Improvements:**

Union College is committed to providing a safe learning environment. Each year we consider upgrades to our fire alarm and sprinkler system network, which includes upgrades to existing fire protection systems as well as an annual inspection and test of all residential fire alarm/sprinkler systems by an outside licensed alarm company. In the summer of 2019, sprinkler systems were installed in West College, Fox Hall, and Webster House. In 2022, fire alarm systems in 319, 321, and 323 Seward Place houses, along with 702 Roger Hull Place, were replaced. In 2023, sprinkler systems were added to the Fieldhouse and Achilles Center. New fire alarm systems were installed in 700, 702, and 704 Roger Hull and 69 Union Ave. Upgrades to the fire alarm system were also completed at Reamer. Future renovations and updates will continue as budgets and circumstances allow.
