

TEMPORARY USE AGREEMENT

by and between

**The Trustees of Union College in the Town of Schenectady in the State of New York
a/k/a Union College**

and

This Agreement is made and entered into this _____ day of _____, 20____, by and between _____ with its main office located at _____, (hereinafter “**ABC**”), on behalf of the _____ (hereinafter “**XYZ**”) which is part of the **ABC**, and The Trustees of Union College in the Town of Schenectady in the State of New York a/k/a Union College, a New York State not-for-profit educational institution with its main office located at Armand V. & Donald S. Feigenbaum Hall, 807 Union Street, Schenectady, New York 12308 (hereinafter “**Union**”).

WHEREAS, **XYZ** has requested temporary use of **Union’s** athletic facility known as **Field** for youth participants enrolled in **XYZ**; and

WHEREAS, **Union** has agreed to allow the temporary use of **Field**, located on **Union’s** campus;

NOW, THEREFORE, it is mutually agreed to as follows:

1. The parties agree that this Agreement shall be for a one-time use of **Field** from _____ a.m./p.m. to _____ a.m./p.m. on _____, 20____.
2. The **OR XYZ** agrees to use **Field** only during the hours designated by this Agreement, which may be modified orally by **Union’s** Athletic Director or his designee on the day of the temporary usage, for contact athletic activities only under the direct and personal supervision of teacher(s) from **XYZ**.
3. The **ABC** and **XYZ** agree to waive, release, and hold harmless **Union** and its trustees, officers, employees, and agents from any and all liability for any injuries incurred by the student participants, chaperones, and teacher(s) involved in **XYZ**.
4. **Union** shall not responsible for any loss, theft, or damage to any property owned by the student participants, chaperones, and teacher(s) involved in **XYZ**, while on or near the **Union** campus.
5. Any action in regard to this Agreement or arising out of its terms and conditions and/or claims that may arise shall be instituted and litigated before the Supreme Court, Fourth Judicial District, Schenectady County, New York State.

6. The **ABC** agree that it has read this entire release, fully understand it, and agree to be bound by it.
7. This Agreement constitutes the entire agreement between the parties. No modification to this Agreement shall be effective unless in writing and signed by both parties.
8. If any part of this Agreement is invalid or illegal, then only that part shall be void and have no effect. All other parts of this Agreement shall remain in full force and effect.
