## 2025-2026 Parent Loan Information Sheet

To be completed by the parent of dependent undergraduate students who wish to borrow a Federal Direct PLUS Loan. The 2025-2026 interest rate is fixed at 8.94% with a 4.228% origination fee deducted from the total amount borrowed. This fee is paid by the borrower to the U.S. Department of Education to cover administrative costs.

### How to apply for a PLUS Loan

1. Complete this form and return it to the Financial Aid Office
2. Apply for a PLUS Loan at [studentaid.gov](http://studentaid.gov) – a credit check will be performed
3. Complete the PLUS Master Promissory Note (MPN) at [studentaid.gov](http://studentaid.gov)

*Parents who add an endorser to the loan or successfully appeal a credit denial will be required to complete a new MPN each year AND complete PLUS Entrance Counseling.*

### How Much to Borrow

You may borrow up to the total cost of attendance (COA) minus all financial aid received (any scholarships, grants, loans the student will borrow and work study if offered). Please refer to the financial aid offer letter in Self Service to see the COA and financial aid amounts. If your student has not granted you Proxy access to Self Service, please ask them to share these details with you.

*\*Note: There is a 4.228% origination fee deducted from the total amount borrowed. This means that if you request a \$10,000 PLUS loan, \$9577 will disburse to your student's account. If you would like to include the origination fee, use this formula: amount you have calculated you need divided by 0.95772. Example: For \$10,000 to be disbursed, the requested loan amount would be \$10,442 ( $10,000 / 0.95772 = 10,442$ )*
